#### Coronavirus: What Can Grangers Do?

The upcoming COVID-19 (coronavirus) pandemic is most likely to be widespread in the US by mid to late March and April. Some Granges have already felt the need to cancel events where crowds will gather. Others are discussing their options. Use your discretion as to what is best for you and your members. The State Grange is reiterating the generally recommended list of precautions that you should take.

- Get enough sleep, drink enough water.
- NO HANDSHAKING! Use a fist bump, slight bow, elbow bump, etc.
- Use ONLY your knuckle to touch light switches. elevator buttons, etc.
- Open doors with your closed fist or hip. · Use disinfectant wipes at the

stores, wiping the handle and child seat in grocery carts.

- Wash your hands often with soap for 10-20 seconds and/or use a greater than 60% alcohol-based hand sanitizer. Use hand sanitizer when hand washing isn't available. It's not quite as effective, but it does help. Can't find? See recipe on page 2
- If possible, cough or sneeze into a disposable tissue and discard. Use your elbow only if you have to. The clothing on your elbow will contain infectious virus that can be passed on for up to a week or more!
