## "150 Years of Grange" Traveling Exhibit

A timeline poster with 24 captioned photographs that highlight the organization's history and accomplishments is the centerpiece of an exhibit for libraries and historical museums. If there's a display case that is larger than the poster, objects (ballot box, sashes, seal, gavel, motto, books, etc.) and photos of Grange halls in the area are added. If there's no display case, an artist's easel that sits on top of a table or low bookcase can hold the poster securely.

The Corvallis-Benton County Library was the first to display the exhibit. Librarian Erin raved about the exhibit and their patrons' response to it. May 1 Jay Sexton moved the exhibit to the Philomath Community Library. A second copy was mounted on a 20' wall at the Sandy Public Library.

## 12 Display Cases! Help!

The biggest challenge will be the Multnomah County Central Library (previously known as the Portland Public Library), which is scheduled for **April 28-June 24, 2018**. All 12 display cases must be filled! They are three different sizes. The four largest are the size of a coffin (3' wide x 6' long).

The library staff were taken by the photo on the timeline of Jeanne Taylor's prize winning quilt block. They wanted assurance that the actual quilt block will be exhibited. While historic photos and newspaper articles can be used, they really want 3-D objects. A plan for the theme of each display case needs to be submitted soon. Then in October a design plan for each display case is required.

So help is needed. If you or your Grange has photos or objects that you think might be appropriate and are willing to loan, please contact Marilyn at m\_reiher@comcast.net. She is also looking for experienced fair booth designers, who would be willing to design a case or two.

The Central Library will host an Opening Reception for the exhibit. They will supply refreshments. They will also print and mail invitations to 500 addresses we supply as well as their own mailing list. We will provide five speakers, each of whom will speak no longer than five minutes. The Oregon State Grange can schedule two programs during the exhibit period. They are looking for demonstrations, not lectures. They clearly have years of experience managing these display cases and know what works.



I hope to see many of you at the Oregon State Grange Convention in Florence, June 24 - 29. The Agriculture Committee will have several activities for your education and entertainment. On Saturday, June 24th at 9 AM we will have the Ag Tour. This year, we will be carpooling for the tour, because renting a bus in Florence was expensive, and because our tour is very short in travel distance-less than five miles total travel. We will visit with the manager of the Florence Farmers Market and see the Market. hear about commercial ocean fishing, and see ice cream being made by hand in a family run shop.

Please reserve your spot on the tour by emailing agdir@orgrange.org or calling my home 541-929-5452. When you sign up please let me know if you can drive and if you have an extra seat or two. The trip will be limited to 40 people and we will return to the Events Center about noon for a free lunch

The Ag Committee will also host two conferences. On Monday, June 26th, at 7:30 am, Elise Higley from Our Family Farms will talk about her organization which advocates for family farms in Southern Oregon. On Thursday, June 29th we will hear from Genie Harden of Spencer

Creek Grange about How to Start a Farmers Market.

In the last issue of the Bulletin I mentioned the Oregon Agricultural Heritage Program, created by a coalition of statewide agriculture and conservation organizations with a common desire to support agriculture and natural resource values in Oregon. This program will start with the passage of a bill in the legislature: HB 3249. At this writing, in early May, HB 3249 is in the House Ways and Means Committee and could still gain passage.

This year's Grange volunteer force at Ag Fest was a big fun group, and I felt that together we made it so no small group had to shoulder too much work over the two days. Thank you volunteers!

coordinating with Hood River County Emergency Operations and First Responders, hosted The Big One 2.0 (Cascadian subduction earthquake). This community-wide event included keynote speaker Dr. Althea Rizzo, geological hazards program coordinator for Oregon Office of Emergency Management.

Dr. Rizzo opened her talk by asking everyone in the room to introduce themselves to each other as these will be the people you need to plan to depend on when disaster strikes. She said there's a 37 percent chance of this huge earthquake happening in the next 50 years. Scientist can't predict exactly when, but we, as citizens can determine whether we're prepared or not.

April 20th Rockford Grange Bringing in 200-plus community members, who participated in hands-on demonstrations. informational booths, tactical gear exhibits didn't only focus on earthquake preparedness, but any kind of disaster emergency.

> This winter was a good example of why citizens need to be prepared. The Gorge experienced the closure of I-84 several times, causing fuel and food shortages, to name just a couple issues. They also experienced an oil train exploding last summer causing a major traffic crisis in both Oregon and Washington for 24 hours. Some commuters were stuck in their cars in sweltering temperatures for eight hours. Rockford Grange is making plans to be a disaster center for their neighbors in the event of a disaster.

Cuddle Cots are manufactured in England and cost approximately \$3000.

Fundraising was kicked-off in February with their 30th annual Sweetheart Breakfast with 100% of the donations for breakfast going to purchasing the Cuddle Cot for the hospital. That amounted to \$1200; a nice start to the project.

Members of Clarkes Grange also visited other Clackamas County Granges that were in the vicinity and whose members would likely make use of, the Oregon City hospital, asking for their help. Seven Clackamas County Granges, Redland, Springwater, Molalla, Maplewood, Abernathy, Harding and Warner, donated between \$100 and \$500 dollars each as well as individual members, the Wankers from Redland and the Heilmans from Abernethy. They received donations from some other community organizations and members as well.

## **Deaf Awareness and** Family Health

Save the Grange Potluck, Please!

My niece's husband recently learned that an undiagnosed allergy to dairy protein may be the source of health problems that have plagued him for years. My sister-in-law - who is an excellent and creative cook — has been hard at work modifying her family dinners to eliminate not just milk but butter, margarine (Yes, it usually contains dairy ingredients), whey products, and cheese. Of course it's not easy, but her goal is that everyone who comes to the table can share the same meal. Sometimes that means there are two kinds of soup or pie. Sauces and dressings are not added before serving. Often there are two options for potatoes. Our favorite family vegetable seems to be the natural partner of dairy foods, but coconut milk and olive oil have their uses

There are foods we all choose or avoid because of health issues, weight control, religious beliefs, and even politics. A wise cook knows efforts to understand and incorporate a special diet also honor the bonds of family and friendship. How do we navigate these considerations with our potluck food?

Think about successful gatherings, as opposed to successful meals. Family health includes good conversation and strong friendships. Potluck should be a low pressure option for busy people, not a competition for the best casserole or the most expensive ingredients. Bring something you like, eat what you can, and learn more about what your Grange friends enjoy. Next time you'll have a better idea of what might tempt them and spark your interest in cooking as well. But it's more important that everyone take the time to sit down and share the day's events, even with their glass of water or their meal replacement shake.

As for the food, simplicity may be the best approach. Be judicious about added cheese, meat, breadcrumbs, or seasoning mixes. Sometimes they're key to the dish, but other times you can easily forgo added ingredients and make your potluck offering accessible to more people. Provide the recipe or ingredient list if you can; it will be appreciated by those who have reason to be cautious.

Back when you couldn't even go into the main hall until you'd taken your four degrees, new members could spend months relegated to visiting in the kitchen and helping with the dishes during Grange meetings. My more recent experience is that Granges have the most egalitarian workforce of any group I know. Everyone helps out because everyone is also needed in the meeting room.

In my Grange we stopped having potlucks before our meetings when we went to one business meeting per month. I'm inspired by other Granges where potluck night is a completely separate time from the business meeting, often with a speaker and open to other invited guests. All of us need to be aware that the concept of potluck food is a red flag for county environmental health departments. You cannot just invite the public to a potluck, but you can invite a friend. Let's make those invitations be sought out by everyone we know as we carry out GrangeUp '17!

## The Multiplying Factor

HALSEY — Generally speaking, Grace Glenn figures she's a pretty good math student. She might be a little behind right now, she said, but she's mostly on track. But her marks don't reflect what the sophomore describes as near-constant frustration with the individually-paced computer labs that have replaced traditional math classes at Central Linn High School.

Glenn turned her frustration into a persuasive essay for a writing class she's taking through Linn-Benton Community College, titled, "Technology should be used sparingly in math classes." In the paper — for which she received an A, she said — Glenn argued math taught on a computer gives students less interaction and can result in diminished performance.

That essay led her to write a letter to the superintendent and school board urging the math program be revamped. In turn, that letter led to changes in the math program that Glenn and her classmates will see as soon as this fall. "I was really shocked," said Glenn, who learned of the planned changes last Monday at a meeting of the Central Linn School Board. "I actually thought they were going to pooh-pooh my paper. I thought they would toss it."

Instead, Glenn said, Superintendent Brian Gardner invited her to be a part of a student panel to gather more input. At the same time, Gardner and Principal Jon Zwemke met with the math department to talk about options. Last Monday, Gardner told the board the plan this fall will be to add back some more sections of traditional math classes for high school students who work better in those conditions.

Glenn's letter wasn't the entire basis for the decision, but it did provide an opportunity to do some more thorough investigation, Gardner said. "Kids are asking for it, it looks like there's a definite need — we're going to try this," Gardner said.

When he joined the district in 2011, Gardner began working to move Central Linn away from a teachercentered, seat-time model and instead toward individual learning and demonstrations of proficiency. The move was in line with both Oregon's shift to the more proficiency-based Common Core State Standards and to changes in diploma requirements, which mandated at least three credits of math, Algebra I or higher.

Math teachers at the high school spent a full year breaking down each math standard, putting together individual study plans and assessments, and reorganizing their class schedules into open math labs. In 2014-15, they launched the new system.

Here's how it works right now: Central Linn's high school math teachers run an open lab in their three adjoining classrooms for students of all grade levels. Students use a laptop to work at their own pace on whichever proficiency standard they need to meet.

Once students feel they get the material and they've practiced enough, they take a test on that standard. Credit is awarded if they pass. If necessary, they go back and work some more, then take a new test that measures the same standard.

Pacing guides set the material at roughly a test per week, said Randy Smith, head of the math department, but not every student holds to that schedule. In fact, there are no firm deadlines, which is part of Glenn's frustration

"We need structure in our world today," she wrote in her letter to the superintendent and board. "With so many things going on that are pressing on our students, such as sports and home lives, we need a system that holds our students accountable and the math program is lacking. "We need to bring back teacher instruction, regular assessing, and add in technology, slowly."

Math teachers agree there's room for improvement in the approach, and they're willing to take what teacher Michelle Mitchell-Foust dubbed a 'necessary step sideways' to bring back some teacher-led classes. "We're bringing back a piece of it for those students who struggle with their own time management or responsibility," said Randy Smith, head of the math department.

Glenn has a valid argument, he added, quipping: "A lot of people like to be told what to do." That said, however, none of the three teachers want to see the proficiency-based, open-ended opportunity

vanish. "It's a balance," Smith said.
"In spite of the resistance, or reluctance, of some, we still feel students are more successful being independent than they were when they were in a timeline dictated by the teacher. Not all students learn at the same rate and not all come with the same set of skills."

Paul Rowton, who teaches developmental math classes at Linn-Benton Community College as well as math at Central Linn, said Central Linn's approach is much more in line with what both college and employers are seeking: self-directed learners who understand the process of a task and can use it to find creative solutions. "This is the direction everyone is starting to push, the whole problem-solving-led curriculum," he said.

Some data suggest the proficiency approach is working. Central Linn's high school scores on state assessment tests, while still below the state average, rose last year from the previous year (earlier tests used a different system and can't be compared). And some students say they love the open lab, said Mitchell-Foust. "I have never seen students so engaged with math in all my years," she said. "That's really cool."

But Glenn, and several parents who spoke at last Monday's board meeting, said some students simply don't learn well with computer-based instruction, or are able to motivate themselves to meet a nonexistent deadline. "I'd love to see hard deadlines, but it's not real realistic for some of the learning

progress that some kids are making," Smith said

Also, deadlines didn't necessarily mean students learned, Gardner pointed out at Monday's meeting. It just meant they could scrape by. "The old system allowed a lato f kids to get through who weren't proficient," he said.

A hybrid system may not solve every problem, but Gardner and the math teachers said they're hoping it will work better for students who need it

When classes resume in the fall, high school will offer six traditional class sections in all, which should serve 120 to 140 of the approximately 300 math students. The students in those classes will be chosen based on those the math department feels will benefit most.

It may turn out to be harder than some expect, Smith warned. Students who have been able to learn at their own pace now will be held to being on the same chapter of the same text as their classmates, whether or not they feel they're ready.

Still, Glenn said she plans to ask to be one of them. "I'm a very visual and audible learner," she said. And, she said, she thinks the district made the right call by keeping both approaches. "I think it's a great balance," she said.

## **London Grange Donates Quilt to Local School Scholarship Fund**





## Legislative Update

Several bills in the 2017 Oregon Legislature have been of interest to the Grange including S.B. 181 which generated considerable activity. It would require all nonprofits to file for property tax exemption every year, with stiff penalties for failure to file including loss of tax-free status for 5 years prior to the infraction, meaning an organization that did not file next year might be assessed property taxes for that year and for 5 years previous. The bill passed the Senate and was referred to the House Revenue committee Several Grangers including District 4 Legislative Chairman Don Kingsborough and OSG Lobbyist Craig Loughridge emailed the

Revenue committee members, and Craig along with Ed Luttrell attended the bill's public hearing and offered testimony. Rep. Phil Barnhardt says he believes this bill would not impact Granges, only 501c3 charitable nonprofits, but we're still concerned and will follow the issue.

Our Legislative conference at State Session will be on Thursday morning June 29 at 7:30am. Craig Loughridge, our new Lobbyist, will be the featured speaker. We will also discuss how to make your resolutions have impact, what happens to resolutions after State session but before Legislative session, and developing effective email networks.

## The US Senate Should Pass Regulatory Reform

The House of Representatives passed its own regulatory reform bill earlier this year. Now, a major bipartisan push is on to pass regulatory reform in the Senate, spearheaded by Senators Rob Portman (R-Ohio) and Heidi Heitkamp (D-N.D.) with their bill S. 951, The Regulatory Accountability Act of 2017. This measure would require a cost-benefit analysis of proposed regulations, invite early public participation on major rules and require federal agencies to disclose the information they rely upon.

It will promote transparency, accountability, and common sense in the regulatory process. Here's how:

- Federal agencies must balance costs and benefits when developing new rules or changing existing regulations.
- Agencies will still produce new rules but will do so in a more transparent manner
- For the most expensive rules, agencies must consider a reasonable number of alternatives and choose the most cost-effective one unless there is a compelling reason otherwise.
- The Act is not expected to significantly impact the length of time for rulemaking. Agencies are already required to analyze costs and benefits, consider reasonable alternatives, and engage the public during rulemaking
- Enactment of the legislation would ensure the current President and future administrations work under these overarching bipartisan practices that drive the regulatory process.
- The Regulatory Accountability Act will allow courts to make sure agencies follow the law regarding the law's procedural requirements.

Grangers from around Oregon flooded the House Revenue Committee with petitions, emails and personal appearances to oppose Senate Bill 181A. The bill requires nonprofit charities to start filing annual returns in order to keep their property tax exemptions. A charity that failed to file, or that made a mistake on its return, would lose its exemption and have to pay five vears' back taxes.

Rep. Bill Kennemer (Oregon City), who met with Grangers at Boring-Damascus Grange on May 3, told the revenue committee on Tuesday that the bill doesn't apply to the

Oregon State Grange, which gain their exemption from a different law than the one being amended by this bill.

Craig Loughridge, OSG Assistant Director for Governmental Affairs, told the committee that the Grange continues to have concerns, even if the bill exempts the Grange. He said "many Granges are registered as public benefit corporations, just as are the public charities this bill goes

Brother. Luttrell noted that the Oregon State Grange Foundation is a charity covered by the bill.

By the time you read this bulletin, the fate of Senate Bill 181 may already have been sealed. Grangers from around Oregon answered the call in May to oppose this bill. Some Grangers emailed. Some sent petitions. Others spoke personally with legislators. All were important in the effort to stall or stop what otherwise would unreasonably increase the paperwork burden on charities across Oregon and threaten their property tax exemptions.

A proponent of the bill in a May 9 hearing before the House Revenue Committee acknowledged that the plan might be broadened to include fraternal organizations like the Grange and other kinds of nonprofits. These organizations already face ever-increasing demands to fill community needs. Every new dollar they must spend in tax is one less dollar to spend on their charitable missions.

## Selective Service System

Recently I was contacted by Michael R. Kalberg Command Sergeant Major, USA (Ret.) State Selective Service Director with a request to assist in locating persons interested in volunteering to serve on local draft boards across the state of Oregon. After obtaining approval of the OSG Master I agreed to provide information via our OSG Bulletin about the need for volunteers. SSS volunteers are the people who review the eligibility status of citizens prior to military service.

Eligibility for local draft board service is straightforward: an applicant must be at least 18 years of age and be registered with the selective service, if required; reside in the county where the draft board has jurisdiction; be willing to devote sufficient time to board duties and to apply selective service laws/ regulations fairly and uniformly. An applicant may not be an active or retired (receiving a pension) member of the armed services or the reserve components; and cannot work in a law enforcement occupation (police/judiciary). Service on a local draft involves a very modest time commitmentno required meetings and not more than eight hours each year to complete on-line training requirements

Mr. Kalberg recently reviewed their board vacancy roster. The most critical vacancies are in Lane, Coos and Jackson counties. Lane County (4), Coos and Jackson Counties (2 each). Other county board vacancies include Multnomah (2), Hood River, Columbia, Tillamook, Washington (2), Polk, Benton, Linn, Marion, Curry, Josephine, Lake, Morrow, Sherman, Harney, Jefferson, Baker and Union.

Those interested in serving can go to the Selective Service System website, www.sss.gov. That site outlines what board service requires and includes an application form.

There is still much going on legislatively and we need to remain constantly vigilant. Remember an email to your legislator is what they prefer, but the good old snail mail or phone call still works, though sometimes timeliness is of the essence and the latter two are not as handy as an email.

This year the Veterans committee will be doing our part of the programat the State Grange Convention a little different. Instead of a conference we will have displays in various places around the building.

## OSG Executive Committee Meeting Minutes - January 21, 2017

The meeting was called to order by State Master Susan Noah at 9:10am. All present except for Secretary Sarah Kingsborough who was missing due to illness. Mark Noah took minutes for the meeting.

Prior meeting minutes October 30, 2016—approved as read.

It was noted that we received thank-you cards from Riley Reynolds for supporting his trip to National Grange; from Rock Wall Grange and Multnomah Grange for approving their grant applications; from Jessie Jo Guttridge for supporting her applications to be National Grange Youth Officer and John Trimble Experience applicant.

#### **Financial Reports**

Celia – Current Reports (further review and discussion after lunch, see below)

#### Timeline for Audit

- Worthy Master reports they are working on posting to December, should be done by end of this month (Jan). Auditors can expect to start in March. A different staff member from the auditing firm will be in charge this time.
- Worthy Master has had more requests for info from trust fund Granges which adds to yearend accounting activity. Also, uncashed checks are becoming a larger problem for the OSG accounting division, especially Pomona Grange dues checks.

Scott Barker – Barker Wealth Advisors – Current Investment reports

- Scott was here at 10am as scheduled and provided quarterly report information as of 12/31/16, with Schwab analysis of expected financial picture for the coming year.
- OSG YTD portfolio return is 6.4%, based on our relatively conservative investment approach. We also earned approximately 3% dividend income in addition to the portfolio growth. Scott led the committee through a detailed examination of our investment portfolio.
- Worthy Master will schedule time for a presentation by Scott at the 2017 State Grange session in Florence.

#### Jan's reports

- Grange Loan update (receivables)
- Coburg West Point plans to pay off their loan in the next quarter. Other Granges who are late with loan payments will receive notices.
- Granges who are late with their dues payments were

- reviewed—several are behind by more than one quarter.
- Contracts on sold properties were reviewed, all are current.
- National Grange will begin paying principal and interest on revised amortization schedule (term was extended by one year).
- Analysis of utility expenses shows some increases to City and for Garbage and Security services, but slight declines in energy expense for both PGE and NW Natural.
- Per resolution at 2016 OSG session, Insurance status for each Subordinate Grange has been collected and was analyzed. We have insurance company name, policy number and expiration date for all Granges. There are only 28 Granges who either have no insurance or did not send in the information required by the resolution.
- EC to look over Visa & Master Card bills. Don Sether reviewed the Worthy Master's credit card expense bills and found no problems.

#### Membership analysis

- Shows loss of 41 members from Q3 to Q4; also loss of one Grange over that period. There have been several consolidations in year 2016 but also several who became dormant.
- List of Granges with 17 or fewer members seems to be getting longer, and there are several under the legal limit of 13 and in danger of being closed. It is hoped that the new Membership Campaign will help these Granges especially, so that they can remain in Active status.
- Junior program showing gains
   Family membership has dropped, most likely due to children 'aging out' of their plan.

#### **Unfinished Business**

- Restraint of Title work still need to cover the following counties: Baker, Clackamas, Crook, Jackson, Jefferson, Curry, Lake, Malheur, Josephine, Marion, Tillamook, Washington, Wheeler. The Worthy Master believes that one or two needed may need to be retyped, not sure of the problems with the other. All others have been filed and are on record.
- √ Worthy Master will work with attorney to develop talking points for Grangers to take to County Clerks and file appropriate documentation for these remaining counties.
- Work was finished on the

- Willakenzie hall and check has been cut for payment. The final bill was \$13,506.46.
- Employee Handbook and Employee Evaluations
  - Sarah was unable to attend this meeting but reported that a computer failure destroyed any progress she had made on this project. Worthy Master will make sure we have something in place in time for our audit in April.
- National Grange selected the amortization that will extend the loan for one more year (see Jan's Loan Updates section, above)
- or GrangeUp '17 is being rolled out tomorrow (January 22) at Irving. All the State Officers, Directors and District Chairs have been requested to be there to select their Granges to visit.
- √ Worthy Master has emailed and notified directors and OSG officers. Weather issues will impact attendance to some degree, unfortunately.
- √ Also at this meeting OSG
  officers will decide on a
  practice schedule.
- With the new budget year we are only paying for one State Deputy, Carol Everman.
   Derrell has agreed to help out for expense money, as has Malcolm Trupp; both will be recognized as Special State Deputies.

#### **New Business**

- North Howell Grange is in escrow. Hall has not been cleaned out, but the sale might close by end of this month. There are a few good chairs still at the hall, and there may also be other paraphernalia or regalia, possibly also dishes and etc. Worthy Master and Brother Don will check out the situation this week.
- Never received an answer on the listing of Franklin – what do we want to do? Ed St. Claire has had it for nearly 5 years, apparently the building is really deteriorating.
  - √ Listing expired in November '16, what is next step? Motion by Don to ask Buzi Nelson to look at the Franklin property and give us her opinion. Seconded by Roger. Additional discussion...the motion carried.
- Deer Creek Grange Wants to partner with the Illinois Valley Fire Department to relocate their current Station #5 to the Deer Creek Grange Property. Nancy would have to draw up a lease. Members of Deer

Creek were planning on being here at 11:00 am but were unable to attend due to the weather.

- The committee reviewed documents provided some questions were raised about the well and septic and access. The EC moved to the Worthy Master's office and a conference call was made to Deer Creek. Their members participating in the conference call were Bill Waggoner, Master; Delaine Sherman, Sec; David Anderson, Overseer; Chris Sherman, Steward of Deer Creek and representing the Fire Dept.; Linda Silva, LAS; and Darlene Anderson, Treasurer.
- Original Fire Dept proposal included a suggestion of \$1000 per year payment from the fire dept, the Deer Creek group suggests that be \$1200 or \$100 per month, and there was no objection from Chris as the FD representative. Question about parking, it needs to be established that the fire dept. has sufficient space. Chis represents the FD and says they have been granted access to the property by the county, so they will not be using the Grange driveway or parking at all. Chris says FD will improve the well house and electric service to it and to the Grange, and upgrade the existing septic system to handle their use. He also says they would return the Grange to pre-existing state if the FD has to withdraw from the project. They are envisioning annual payments on Jan 31 of each year.
- WM states that OSG will have our attorney submit a lease document based on existing examples, for them to review and approve.
- WM asks about timeline, Chris says they would like to act asap, hoping to start construction as soon as weather permits. Worthy Master will talk to attorney and try to have initial paperwork for Deer Creek members to review, asap. FD intends to make a full year payment for 2017 when this agreement is approved. Jeff asks, if the Grange fails, what would FD expect? They would continue payment to OSG for duration of dormancy, then expect right of first refusal after that dormancy period.
- √ Worthy Master will call attorney Nancy Murray asap



## OSG Executive Committee Meeting Minutes - continued

- √ Worthy Master will call attorney Nancy Murray asap to get this rolling but it will probably take a month or more...Chris seems OK with this, as does the rest of the Deer Creek Grange group.
- After the conference call, Jeff moves to allow Illinois Valley RFD to lease a portion of the Deer Creek property as described in the IFRFD proposal. Don seconded the motion. The motion was approved. The Worthy Master will contact attorney Nancy Murray regarding the lease paperwork. Questions to resolve, are they digging a new septic or running their line to the existing septic? Also, will the electric improvements include a separate drop-line and meter for the FD?
- Matching Grant information— One Grange has recommended that the State Grange consider a follow up Grant that targets membership development to those who have successfully completed the original Matching Grant. There was discussion about this idea, possible funding strategies, etc.
- A loan of \$4,383 was made to Goshen. They would like to pay \$100/month as a minimum and if they can do more they will. Don moved to accept the proposed terms, \$100/month payments at 5% interest. Seconded by Jeff. Some additional discussion. The motion carried.
- We need to discuss and develop a "Collections and Preservations Policy" for the Oregon State Grange, and find a volunteer to continue on with the scanning started by Ed Luttrell.
  - The committee reviewed the State Grange of Minnesota Collections Policy.
- The Worthy Master suggests this should remain an agenda item for future EC meetings. There was discussion about what should be saved, where and how to save or store things, & whether there might be grant money available for such preservation projects. Grange materials in private possession ought to be properly labeled so non-members who encounter them will know what to do with them. Records ought to be digitized and stored in searchable format. We should have a policy for the distribution or dispersal of various items that are routinely encountered when a Grange goes dormant.

Lunch Break

- We returned to Financial
   Celia discussed balance
  - Celia discussed balance sheets, current reports and individual fund accounts.
  - National wants their payments based on National Database. We will need extra help to get it completely caught up. Either volunteer or part- time help.
  - National Grange is asking for more data than we have collected in the past. Discussed ways of getting help and the cost. Don moved, Roger seconds, to authorize up to \$1500 for short-term paid help to get this data entered. Discussion followed. The motion was adopted.
  - Regarding the Moss Adams recommendation to add off site storage for data backup we have taken a first step and have purchased another disc drive. As soon as we make sure that the backup includes all pertinent programs and documents we will purchase a second and swap once a week.
  - Lobbyist Received a letter from Deschutes Pomona urging us to appoint or hire a lobbyist for the Oregon State Grange as the earliest possible date. Executive Committee discussed varying strategies to accomplish this...there is no budget to hire a lobbyist, even if we had the funds we would not likely get much representation for what we used to pay. Best idea might be to find a volunteer or volunteers who will monitor the session activities and provide updates via the Legislative Director and local committees. Our former lobbyist Jim Welsh offered to meet with Leg Dir Mark Noah to discuss these issues and provide some input. Former lobbyist Ed Luttrell also offered support and advice. Perhaps our various District Directors could monitor, suggest issues and information that ought to be distributed, and initiate this through the OSG Leg Director or State Master.
  - State Master's conference coming up in February. Worthy Master will be attending, also possibly the first gentleman. This one is in Connecticut, and most of the Western States want this to come to the West Coast.
  - Contract for Clatsop County Fairgrounds for 2018 State Session was presented for review.
  - This location is the choice of the District committee for 2018. It will be similar to Benton County Fairgrounds

- regarding amenities. Jeff moved that the District 3 2018 steering committee recommendation of Clatsop County Fairgrounds location for the 2018 session be approved. Seconded by Roger, and the motion carried.
- Policy for virtual attendance at meetings. National Grange formally decided that State Granges should make their own policies regarding virtual attendance. There was extensive discussion and the consensus is that we need to develop such a policy asap. Don moved that we table this issue until our April meeting. Roger seconded the motion. The motion carried.
- Request from Warren Grange for trust funds. Requesting \$2400; Don moved to accept the request, Jeff seconded, and the motion carried.

#### Decisions made via email

- Agreement to allow Springwater to withdraw \$4,200 from their trust funds for various projects and expenses.
- Agreement to counter the \$50,000 Crowfoot offer with one of \$60,000.
- Agreement to allow Fruitdale Grange to withdraw \$1,150 from their trust funds for work on their water system
- Agreement to loan Goshen up to \$4,983 to pay Nancy Murrays bill. Bill turned out to be only \$4,383.00
- Agreement to sell North Howell for the listing price of \$210,000.
- Agreement to allow Keizer to withdraw \$862.45 from their trust fund for work on their shed and some clean up around the building.
- Agreement to counter the \$20,000 Crowfoot offer with one of \$80,000 (prior to the \$50,000 offer) – counter was not accepted.
- Agreement to allow Sandlake Grange to withdraw \$5,617 from their trust funds for a heat pump and some building repairs in the form of exterior wall replacement and roof maintenance.
- Agreement to allow Keizer to withdraw funds from their trust fund in the amount of \$50.25 to pay for changing the locks on the building.
- Motion by Jeff to affirm these decisions and include them in the minutes of this meeting. Seconded by Roger, and the motion carried.

#### **Grange Reports**

 Chenowith - The Worthy Master has the signed

- agreement back and just needs to get it notarized and sent in and that property should be off our hands.
- Crowfoot The last offer we countered went away, but Buzi thinks we may be getting another one.
- Fair Oaks Nothing is happening.
- Franklin discussed previously during this meeting
- Gold Hill Buzi seems to think that we may be getting an offer on this soon.
- Goshen discussed previously during this meeting. Also, some discussion regarding their problem evicting their renter/ caretaker. They have only been there a couple months so eviction should not be complicated.
- Keizer They have not paid dues for three quarters and have been sent a letter
- Lookout Mountain/ **Terrebonne** – The former Lookout Mountain hall has been sold for \$50,000, netting \$45,595.50. The State Grange was sent a check for \$44,595.50, leaving the other \$1.000 for Terrebonne. They were informed by the State Master to close out their bank account and to send all of it on to Terrebonne including the \$1,000 from the sale of property.
- Milwaukie & Hillsboro –

  one. One was scheduled with
  Hillsboro but the weather got
  in the way and it was cancelled,
  to be rescheduled before the
  end of January.
- Mud Springs—Buzi plans on contacting the people who were interested last year to see if they still have any interest. She reported just today that there was a break-in last night (1/21/17) involving some broken windows. The perpetrator was caught in the act. She'll coordinate with local people to make sure broken windows are boarded up.
- North Howell discussed previously at this meeting
- Salmon River State Deputy Carol Everman reported they may be resolving their issues with members living on the property in RVs. They still have some issues regarding articles for sale accumulating in or around the building. They are working on resolving parking issues and marking the 'no parking' areas.

## **Morning Star Grange Donates Food**
