
GRANGE HALL USE & HOLD HARMLESS AGREEMENT TERMS AND CONDITIONS

READ THE FOLLOWING TERMS AND CONDITIONS, THEN INITIAL THE CORRESPONDING LINE TO INDICATE YOUR AGREEMENT:

#1. CHECK ONLY ONE:
Yes NO ALCOHOLIC BEVERAGES WILL BE SERVED OR ALLOWED ON THE PREMISES. Any appointed Grange Representative may, at any time, inspect the Premises and if any alcoholic beverage or other intoxicating or controlled substance is evident, the Grange Representative shall reserve the exclusive right to immediately stop any activity and close the hall, and all use fees and/or deposits paid by the User will be immediately forfeited.
