## 2013 State Grange Session

Come to the Land of Plenty June 16-21st in Canby, Oregon for the 140th Oregon State Grange Convention. There has been a venue change since the previously announced location in Gladstone, Oregon. We are delighted to share with you the Canby Grove Christian Center, located just a few miles off I-5 in Canby, Oregon. Canby Grove has just over 74 acres of land and some 150 buildings. It operates year-round with a fulltime staff of professionals to accommodate groups in numerous cabins and bunkhouses, in addition to RV camping sites. There are 15 different meeting spaces on site, with seating capacities from 20 to 900. Meeting rooms are equipped with modern audio/ visual equipment to make hearing and seeing actions of the State Oregon Grange Convention easy for all. Canby Grove also has a full-service dining facility to host our luncheon banquets, as well as, breakfasts and dinners. Meal information and advance ticket sales will be available with the March bulletin. Grange members will enjoy the peace and serenity of the outdoors in this woodland camp set on the banks of the Molalla River. Additional facility accommodations include a ball field, playground, hiking trails,

swimming pool, campfire, handicap access, Wi-Fi, and more.

The District 4 hosting committee apologizes for any inconvenience in changing locations if you previously made reservations for Gladstone. RV parking and cabins/bunkhouses are available on site. A reservation form is located in this Bulletin and at orgrange.org, and is required to reserve housing on site. We have also provided a list of hotels and motels, all located within 5 miles of the camp, for you to make your lodging reservations.

Many preparations are underway for a great convention this year. If you have not previously attended the Oregon State Grange Convention, we hope this will be the year you come. We are delighted to share our section of Oregon with you along with the fellowship, networking, banquets, degrees, policy work, and traditions of the annual session. We'll see you in June in Canby!

### **Dues Are Due**

I am assuming that all secretaries have sent out the dues notices for their members. Those members who have not yet paid their 2013 dues now need to be sent the 2nd notice. The 3rd notice is the "Intent to Suspend" and should be sent out prior to your March meeting. Members with unpaid dues as of March 31st can be listed on the 1st Quarter Membership Report as being dropped for Non Payment of Dues (NPD). (A member must be in arrears for one quarter to be dropped, since that report is not read and adopted until the April meeting a member can pay by March 31<sup>st</sup> and be OK. / You then need to notify the "former" member with a "Notice of Suspension" that informs the person that they have officially been removed from the membership rolls. ## kick-off to new Membership Campaign

Called the 13Second Campaign, the initiative encourages all members using social media such as Facebook and Twitter to post a personal status or tweet on the 13th of every month from December 2012 through December 2013 – a total of at least 13 posts – that tell a personal story of what the Grange means to you and encouraging nonmembers to ask for more information or to join.

M e m b e r s h i p / Leadership Director Michael Martin said the campaign allows every member to show "I ask that members across the country, that means you personally, take time – about 13 seconds – on the 13th of each month, starting today to post to your social networks a kind of social media elevator post," Martin said. "These posts should tell a brief anecdote about the Grange's importance in your community and in your life, and they should encourage your social media friends to ask you more about our Order."

Grangers who participate are encouraged to end each of their tweets or posts with #13Seconds so the National Grange can see how many messages were posted, shared and discussed, determine what stories and anecdotes seem to draw the most attention and assist in other areas of membership and recruitment.

"I challenge you to do your part by actively participating in this campaign. Actively tell people about your positive Grange experience and ask at least 13 people to join the Grange between now and December 13, 2013," Martin said.

If you participate and have success, Martin asks that you share the information with him by email at <u>mmartin@nationalgrange.org</u>. Include in the email your name and name and number of your Grange. Include the post that prompted the new member to join and the new member's name and Grange.

How important do you feel the Lecturer of you Grange is? Our Subordinate Grange Manual states that the Lecturer is assigned the important duty of leading the literary program and the educational work of the grange.

In planning your program check with your Master/ President, at least two weeks prior to the meeting to see how much time is allowed for your program. If he says there is no time, think of having Lecturer's program prior to the meeting, especially if you have an outside speaker who is not a Grange member. Also, remember always have a Grange application ready to hand to the speaker after question time. Never miss a chance to invite the speaker to attend a upcoming meeting or staying for the evening meeting.

Every Lecturer has to be creative to look for ideas for their program. There are many sources to assist you. ## The lobbyist's Report

The 2013 Legislature – Link to all Legislative Information http:// www.leg.state.or.us/

Republican Whip. Co-Speaker Bruce Hanna has chosen to step down from a leadership role this Session.

The House Democrats have selected as their 2013 leaders Tina Kotek (Dist. - 44, Portland) who will also be voted in as the Speaker of the House by the Democrat majority in the House, and Rep. Val Hoyle (Dist. 14 -Eugene) was chosen as Majority Leader. The Senate Democrats have selected Senator Peter Courtney (Dist.-11, Salem) as Senate President and Sen. Diane Rosenbaum (Dist. 21-Portland) as Senate Democrat Majority Senate President Leader. Courtney made this comment after being selected again, "I have always believed that the Senate President is president of the entire Senate," Courtney said. "We will face difficult challenges in the next session and it has never been more important for Democrats and Republicans to work together to address the issues that matter most to the people of Oregon." Senator Rosenbaum's comment after her selection, "...I look forward to working in the upcoming 2013 session to focus on the right priorities: jobs, quality education and standing up for middle class Oregonians and small businesses."

### OSG Legislation in 2013

Presently, OSG has sponsored two bills resulting from the 2012 Annual Conference as approved by a majority of Delegates. The first Bill will legislatively represent OSG Resolution HW #1: Newborn Drug Screening, with the intent that each newborn child, in Oregon, shall receive a newborn drug screening test within one month of the date of birth. The second Bill will legislatively represent OSG Resolution HW #2: Certificate of Birth Resulting in Stillbirth, with the intent that the legislation would grant a parent the ability to apply to the state Department of Health for the certificate, known as the Certificate of Birth Resulting in Stillbirth, for the child. Several other similar Grange Resolution concepts will be sponsored by other Legislators, individuals, and organizations. Labor Commissioner, Brad Avakian is sponsoring legislation similar to Grange ED #2: Career and Technical Education Teaching Licenses. The District Attorney Organization may have a bill that we could convince Legislators to amend in our "No Contact" order violations (LE #1). There is a special O&C Joint Task Force Co-Chaired by Rep. Hanna and Rep. Hoyle which could include an opportunity to ask for action on OSG Resolution

### Enforce the O&C Act on all O&C Lands (LE #2).

There are no Legislative Concepts at this time on OSG Resolution Tenth Amendment (LE #3). However, due to the escalating "Gun Violence" and "Obama Care" subjects nationally, there may be a renewed interest in States Rights issues. And, to note, our Governor could be described as one of the strongest States Rights Governors in office. With the escalation of action and emotion involving the gun issue nationwide the OSG Resolutions Concealed Carry (LE # 4 and LE  $\underline{\#}6$  will be taking a back seat to efforts for more "Gun Regulation" this Session.

OSG Resolution for Veterans Preference for Low-income Housing (VE # 2) is included in a work group addressing this issue and we will have the opportunity to be a sponsoring organization to help move this forward. OSG Resolution Market Vendor Insurance (FI #1) received a response from the State Insurance Division that will be published in the Grange Bulletin this month.

### More 2013 Legislative Issue **Proposals**

This first round of bills added up to around 1200 new bills. Some represent new tax proposals, one in particular introduced by the League of Oregon Cities, would require an Oregon constitutional amendment, and if passed would give Oregon a California style taxing system which amends Measure 50 tax law. Some of the other tax reform ideas floating around will also need changes to our Oregon Constitution. And, if you don't already suspect that most of these Legislative proposals will cost most of us more money on an annual basis, please be aware that they will.

Another Legislative proposal we have heard about which may or may not cost you more is the proposal for a "mileage tax" which would require you to pay a per/mile fee/tax for traveling on the roads of our state (not including private roads and maybe county roads). This proposal will be directed at the fuel efficient automobiles that attain 55 miles or more per gallon efficiency. They may be required to report their mileage, include GPS tracking technology, or pay a flat fee. These issues will be determined during the Legislative committee work.

force meetings with the Water Resources Department it is apparent they need to provide more information on whether or not there will be a cap on the amount assessed due to the number of water rights held or accumulative dollar amount. Also, just what they are going to use the money for, in detail, and whether or not this will be an ongoing fee or a stop-gap measure during our present economic recession? The answer, partially, to that question is whether or not we will be successful in placing a sunset provision in the bill. Most often, a new fee or tax, once instituted, is not eliminated in the future because the bureaucracy always has a way to spend your dollars. And, on the same subject of water fees and taxes, we are anticipating the proposal for a broader water fee/tax that will include everyone using water including those of us on wells.

For years the Oregon State Fair has been running in a deficit and now that the Fair, under the control and management of the State Parks & Expo-Center, has established some black ink financially, there is another piece of legislation to make some significant changes to move the Fair under the control and management of the Oregon Tourism Commission. This may be a good move, but there is always the concern no matter where the Fair is placed, for control and management, there needs to be full understanding of how important agriculture is to their future existence.

With the most recent hype and attention placed on Genetically Modified Organisms (GMO) and Genetically Modified Crops (GMC), especially in Jackson County, we anticipate legislation to address growing GMCs in Oregon.

Some of the agriculture community will be supporting the proposal to roll back the Driver ID requirements that became law in 2008. The more stringent present requirements, some have said, are unduly restricting some employees from being able to drive to work. Governor Kitzhaber commissioned a task force to look into this issue to determine whether or not there is legislation that can be drafted to keep people safe on the roads and let employees travel to work. This may be a fairly difficult task to accomplish due to the recent work and resulting legislation on the subject.

Each Legislative Session has its' own challenges, and the 2013 Session isn't expected to stand alone in history. The Oregon House of Representatives will be populated with 34 Democrats and 26 Republicans, and the Senate will be populated with 16 Democrats and 14 Republicans. The House Republicans have chosen their leadership for the 2013 Legislative Session. Rep. Mike McLane (R-Powell Butte) was chosen by his caucus members as the new House Republican Leader along with Rep. Julie Parrish (R-West Linn) as the new Deputy Republican Leader and Rep. Vicki Berger (R-Salem) as the new House

Look out the windows of Columbia Grange #267 and you will see one of America's most iconic places - the mighty Columbia River Gorge surrounded by wilderness. Columbia Grange #267, situated on a hill overlooking this scenic beauty, can now look inward as well. The 103 year old building has had another face - lift. Grange Master Brad McCarty viewed the finishing touches of the interior paint job this week saying, "It looks great, doesn't it?"

Like so much at this Grange, the painting of the interior wall and ceiling was a volunteer effort undertaken by several individuals. Arnold Dufresne, director of the 501(c)3 Columbia Gorge Helping Hands Food Salvage program, was instrumental in bringing the painting renovation about. "What else?" asked Scott, mentally deciding that the immense work of a new roof might be beyond his volunteerism. "Well, as a Grange, we have been talking about repainting the interior for years now.....even picked out the colors," replied Dufresne. The longstanding deep tan and brown interior had kept the Grange Hall looking dark and uninviting.

After а moment's reflection, Scott said, "If you can wait until January, I can help." Ron Scott enlisted the aid of two friends, Don Haevisher and Mike Thomas, and the three reappeared mid - January with paint and equipment. They transformed the interior space in one weekend. Now, the bright walls and ceiling, set off with a medium green for the trim, make the large space clean-looking and inviting. The Grange membership is now ordering comfortable cushions for the long wooden wall-benches.

Several years ago, Columbia Grange addressed the dilapidated state of the building's exterior in a large renovation. Now, just the roof and floors need attention. The membership - and the community - is grateful for the volunteer efforts of Ron Scott, Don Haevisher, and Mike Thomas in creating the welcoming, fresh look of the often busy Hall.



## London Grange #937 QUILT BLOCK CONTEST

- We need to know how many folks want to participate in the 2013 Quilt Block contest by or before <u>March 1</u>, <u>2013</u> so we'll have time to assemble fabric packets. London GWA will furnish you with a packet containing 5 pieces of fabric, each measuring about 10"x12"
- At the suggestion of the Pomona GWA the cost for each fabric packet is \$10 to be paid to Elaine Chapman (for the London GWA) which will help pay for the fabric purchased. You can buy more than one packet and make more than one quilt block. Quilt Blocks may be made by any Grange member in Oregon.

- Deadline for completion of quilt blocks is <u>July 13, 2013</u>. Quilt Blocks are to be brought to the Lane Pomona Grange meeting at Walterville Grange by 10:00 a.m. If you're not able to come to the Pomona meeting, quilt blocks should be mailed to Elaine Chapman, at 1534 Jason Lee Avenue, Cottage Grove, OR 97424 <u>at least</u> <u>one week before</u> Pomona meeting. - Quilt Blocks become the property of London GWA and will be displayed at the July 13<sup>th</sup> Pomona meeting where we'll have a "People's Choice" vote on all the quilt blocks submitted. The maker of the winning quilt block will be awarded a prize.





