

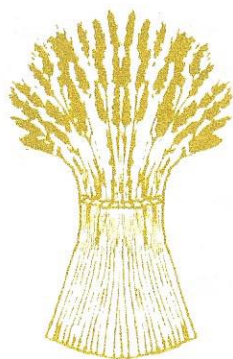
## Recognition

✧	Silver	\$500.00
✧	Gold	\$1,000.00
✧	Platinum	\$10,000.00

## Through the Oregon State Grange Foundation

The Oregon State Grange Foundation was established in 1993 to fill a need for a nonprofit charitable entity. It enables Contributions to the educational and charitable goals of the Grange in a manner that will benefit the donor as well as the Foundation.

The Trustees are committed to realizing the Mission Statement of the Oregon State Grange Foundation. Our goals are to better serve the enduring ideals and principles of the Grange and Oregon.

The Internal Revenue Service recognizes the Foundation's exemption from income tax under Section 501 (c)(3) of the Internal Revenue Code, and Oregon's Revised Statutes, Chapter 65.

The Foundation is overseen by seven Trustees. Six represent each of the six districts and the seventh is the State Grange Master.

Trustees are elected at the annual meeting by the Grange members present and serve a 5-year term with a limit of two terms.

## Donate

You may donate to the Oregon State Grange Foundation in a number of ways. Bequests, legacies, devises, or transfers to the Foundation are deductible for Federal estate and gift tax purposes. Please consult your CPA or tax planner for how you can best take advantage of a tax deductible gift to the Foundation.

## What Kind of Contributions

There are several options for giving gifts to your Foundation.

- ❖ **Cash:** This can be a straight donation, a life insurance benefit to the Foundation, or a transfer of a payable contract. You can also create a trust with the Foundation as the beneficiary.
- ❖ **Securities:** Such as stocks, bonds and mutual funds.
- ❖ **Real Property:** Land, with or without buildings. Property can be in urban or rural settings.
- ❖ **Personal Property:** Vehicles, antiques, collectibles, other items.
- ❖ **Services:** You may provide needed services, such as printing or brochures to the Foundation.

## For What Purpose

- ❖ **General Fund:** Your donation can be a general fund donation, which will be used where needed the most. It may also be directed, in part or completely, to any of the special funds of the Foundation which include, but are not limited to, the following:

## Educational

- ❖ **Camp Fund:** The income earned on this fund each year is made available to the Oregon State Grange Junior Department to help with the costs of a state wide Junior Camp event.
- ❖ **Junior Camp Scholarship Fund:** To assist a Junior Grange member to attend Junior Camp
- ❖ **Memorial Scholarship Fund:** A scholarship fund can be created to honor any person. This can be a one-time only or perpetual scholarship.
- ❖ **Marcel "Muzzy" Mandel Memorial Scholarship Fund:** This scholarship honors the memory of Muzzy Mandel of Sherwood Grange.
- ❖ **Mary Helen Sauter Ramm Memorial Scholarship Fund:** The scholarship honors Mary Ramm.

## Service

- ❖ **Fraternal Concern Fund:** To assist those members in need.
- ❖ **Stage Fund:** To assist the State Grange in the purchase of a modular stage.
- ❖ **Cat Thomas Hearing Impaired Fund:** To assist members with hearing disabilities.
- ❖ **Individual Endowment Fund:** To provide for a program or activity that you wish to see continued into the future or to further the mission of the Oregon State Grange Foundation. Minimum level for establishing an individual endowment is \$10,000.
