## 139th Annual Session June 10-15 in Seaside

This year's State Session theme is "Follow the Light to Seaside." The convention will be held at the Seaside Convention Center, which is located at 415 First Avenue. District #3 Grangers from Clatsop, Columbia, Tillamook, Washington, and Yamhill Counties have been preparing to welcome you for more than two years.

### Registration

Registration begins at noon on Sunday June 10 and closes at 5 pm that afternoon but will be open from 8 am to 5 pm daily to accommodate those arriving midweek. Everyone must register (except 5<sup>th</sup> & 6<sup>th</sup> Degree team members who only attend the Degrees). The registration fee is:

Delegate	\$15
Non-delegate who wants a delegate's packet	\$15
Two delegates from the same Grange (2 packets)	\$25
Family of two or more (2 packets)	\$25
Visitor or guest without a delegate's packet	\$5

Every Grange should send two delegates to vote on resolutions that affect State Grange policy. All members are encouraged to attend as visitors for a day or the entire week. This is an opportunity to learn more about the Grange, exchange successful fundraising, membership recruitment, and community service ideas, and have a good time.

Pre-registration is advised to make the line move faster. The Pre-registration form is printed elsewhere in this edition of the Bulletin and is due with payment to the State Grange office in Salem by **Friday, June 1**.

Bring your contest entries (GWA, Lecturer's, and Juniors) to their rooms from noon to 5 pm on Sunday or 9 am to noon on Monday. These rooms are on the second level, but there's an elevator!

Bring your Community Service donations for the South County Community Food Bank to the Necanicum room. This year we are urging donations of necessities not covered by SNAP (Supplemental Nutrition Assistance Program), such as toilet paper, bar soap, shampoo, toothpaste and brushes, and pet food.

### No Ticket, No Meal

Meal tickets must be reserved by **June 1**; the Meal Ticket Order form is printed elsewhere in this edition of the Bulletin. The caterer requires a firm headcount in advance, so the only tickets to be sold during the session are those turned in by those who cannot use them.

Dinners are "on your own" at one of the many restaurants in walking distance or back at your motel or RV. **No "outside food" is allowed in the Convention Center.** This means no fast food bags or wrappers and no over-sized drink or coffee cups. A coffee vendor will sell coffee drinks before we open each morning. The youth will sell bottled water and packaged snacks.

The Grange Benefits Breakfast is served from 7 to 9 am on Tuesday at Pacific Grange, 90475 Hwy 101, Warrenton, which is 7 miles North of the Convention Center. There may be no such thing as a free lunch, but this is a **free** breakfast.

## The Master's Column

I have been pondering over the phrase "Best Practices" as it relates to our Grange work. Anyone who is or has recently been in a corporate setting has heard this term used. According to Wikipedia, "Best practices are used to maintain quality as an alternative to mandatory legislated standards and can be based on self-assessment or benchmarking." The National Grange Digest of Laws provides mandatory legislative standards but there is room for variation on the fine points. For instance, the Digest tells us we are required to open our meetings in full form and includes some specific instructions, to wit: There must be a quorum of 7 members, a flag and bible. But the Digest actually states that the flag may be saluted in place rather than presented on the floor, so which is best? If you have music and officers willing to march, then the flag presentation ceremony is the Best Practice for your Grange, but if your Ceres can't march and you have no musician then saluting the flag in place is your Best Practice. Both are allowed under the Digest of Laws.

It is generally accepted that a hall will be set up with stations in the correct places as described in the 4<sup>th</sup> Degree Manual. But if you usually have a small crowd at meetings and some members are hard of hearing, a Best Practice for your Grange might be to move the stations much closer together while still maintaining a Grange hall layout. If your hall is upstairs and some members can't climb the stairs, or if the main hall is big and cold and expensive to heat in winter, you may have good reason to meet in smaller quarters like the dining room or a smaller meeting room. If you seat your officers according to the Grange floor layout, even if your group is arranged around a table, and if you open the Grange according to the Digest, salute the flag, follow the order of business and conduct your meeting according to Roberts Rules and the Grange Parliamentary Guide then you have created Best Practices that

suit your own situation and still comply with the Digest. The danger here is in cutting corners. What is the difference between a Grange that condenses its meeting hall down to the size of several tables pushed together, versus one that just 'meets around a table'? The first one is trying to maintain the Best Practices of their Grange, and the second one is in violation of the Digest of Laws. The first one will probably maintain the order and decorum of a Grange meeting and finish its business efficiently, and the second one will probably turn into a long-winded chat-fest that accomplishes little. It so often is true that the right way, though it appears longer, is the quicker and easier way after all. Some Granges are starting to use the 'Alternative Manual' instead of the traditional Subordinate Grange Manual. The Digest gives us this flexibility, and some of our newer members prefer the updated language and titles. I will always prefer the traditional text and officer titles but will fully support any Grange who chooses the Alternative. Actually we are seeing a trend in that people are becoming more interested in the traditional ceremonies and ritual work after they have had a chance to learn more about Grange. The GROW club and friends exemplified the first four degrees at Bellview Grange on Sunday April 15 for a very appreciative crowd, and frankly it was the first time I had been a part of these degrees in a long time so it was a great refresher, reminding me just how interesting and inspiring these ceremonies can be.

What does it mean to be Master (or President) of your Grange? It means you must be dedicated to the pursuit of fair and open dialogue. You must remain impartial at all times so none are intimidated into silence or feel that their vote does not matter. You must allow all members to speak, even if you do not agree with them, as long as decorum is maintained. You must accept the will of the majority and you can't vote (unless by paper ballot). But the position also teaches many things. You get good at keeping order while keeping friends. You learn the ins and outs of parliamentary procedure. You aren't worried about running a meeting in front of a crowd of people. You become a better leader, and a better Granger, and a better public speaker. You learn the truth about a lot of old sayings like 'You can catch more flies with honey than with vinegar'; 'You can lead a horse to water but you can't make him drink'; 'It's easier to pull a chain than it is to push one'. You figure out that if you can

make whitewashing a fence look like fun, everyone will want in on it. You improve your Grange and yourself. You get far more from Grange than you could ever give back. See you in Seaside. I'll be the relaxed-looking guy in the Hawaiian shirt at 1:30 on Friday!



## Death Claims OSG Attorney Don Willner

Don Shelley Willner, 85, passed away March 27 at his home in Trout Lake, Wash. He served 40 years as the Oregon State Grange attorney. He was born in New York City and was graduated from Harvard Law School in 1951 after serving in the Maritime Service and U.S. Army. He practiced law in Washington D.C. but moved to Portland in 1952. His law practice focused on labor, civil rights and environmental issues. In 2010, he was awarded the Pacific Northwest Labor History Association's 'Person of the Year'.

In 1957, he was elected to the Oregon legislature and in 1963 began a 10-year tenure as a state senator. While serving in the legislature, he drafted and promoted the Oregon Scenic Waterways initiative of 1970 and the Oregon Bottle Bill of 1971. He worked on some of the first civil rights laws in Oregon and chaired the Committee on Migratory Labor, helping to improve conditions for migrant workers and fighting for their rights to form a union. He worked with Cesar Chavez and served as lawyer for Colegio Cesar Chavez in Mt. Angel, one of the first Latino colleges. Mr. Willner was an avid tennis player, nationally ranked in men's singles and doubles into his 80s. He carried his tennis racket wherever he traveled. He was buried in his tennis whites. He found great enjoyment in biking and hiking and loved to travel.

"He was a lion of a lawyer," said Nancy Murray, a Portland attorney, who has agreed to work for some of Willner's clients - including the Oregon State Grange. Survivors include his wife, Marjorie Burns; four daughters; three stepsons; a stepdaughter; nine grandchildren and his first wife, Patience Willner.

## Community Service Report

For over 10 years now, we have been conducting food drives at each of our State Sessions and then donating that food to the local food bank where we are meeting. This tradition started, we believe, when we met in Clackamas County at West Linn in 1998.

Since that very first drive, we have collected over 60,000 pounds of food for the needy. Only in recent years have we begun to donate money in earnest along with the cans of food, and it is that money we wish to talk about here. One of the most urgent needs among the needy when they go to a food bank is for paper products and non-food items such as diapers (if they have young children). Depending on their circumstances, if a family is receiving "Food Stamps", those funds received in their monthly allotment do not include provisions for purchasing toilet paper, diapers, or other non-food products for their family. The money we donate at our food drive helps that food bank purchase more food or the needed non-food products that are people needs. When they use the money to buy food, they usually can purchase from the Oregon Food Bank in Portland of other suppliers using a ratio previously set up by the organization. We often hear things like "One dollar will buy an additional 12 pounds of food" or something similar. What that means is that they are paying the shipping costs of the Oregon Food Bank (who never charge for the food they give away) that are incurred during processing and shipping of the food through their distribution network. When I (Ken Phillips) was a VISTA volunteer in 1983-4, I was in charge of creating the Josephine County Food Bank and its distribution system of participating local food banks. Back then, shipping was a big part of our expenses and we always had to pass on our costs onto the recipient food bank. It was a nominal fee back then, but now with high gas and diesel costs, it is much higher. It is these shipping costs that food banks have to pay to receive food from the Oregon Food Bank, based on a ratio determined upon by the Oregon Food Bank. For the South County Community Food Bank, that rate is \$1.00/ 5.55 Lbs. So, when your Grange brings up the discussion on what how much food or an amount to donate this year to the food drive, please remember these extenuating circumstances? Any amount will be

- H. The top three winners in each category will receive the following:

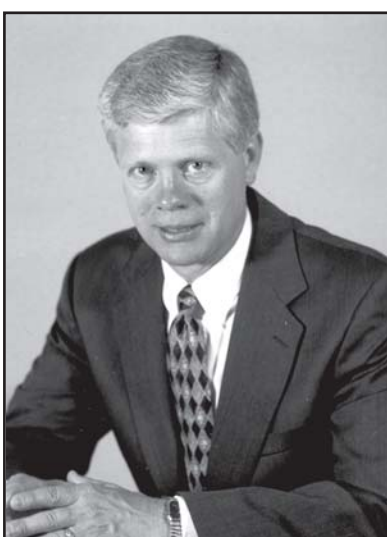
First Place Winners: \$25 plus a season pass to the Fair.

## Legislative Report By Jim Welsh



### 2012 Legislative Session

#### Good Legislation Passed

#### Tax Credit for Wolf Predation - HB 4005 Passed

Rep. Bob Jenson introduced HB 4005 in order to establish a refundable credit against income taxes compensating for livestock killed by wolves. This bill passed both the House and Senate with a very large bi-partisan favorable vote, and signed by the Governor. The livestock industry is grateful for the continued support from Legislators interested in helping alleviate the cost of wolf predation in Oregon.

#### HB 4006 - Consultation and Coordination Required if Species Listed Passed

HB 4006 specifies that before State Fish and Wildlife Commission makes determination that a species is threatened or endangered the Commission shall also consult and coordinate with private landowners, affected cities, affected counties and affected local service districts. This identical legislation was introduced in 2011 by Judge Grasty from Harney County and has received a large amount of support, especially in the House. OCA supported this legislation in 2011 and has continued helping pass this legislation in the February Session. HB 4006 passed the House with all but four yea votes.

#### SB 1582 - Wetlands Delineation Changes Passed

Sen. Morse and Rep. Olson introduced the bill to address

certain difficulties property owners have with wetland delineations. The bill in no way lessens the intent to preserve wetlands, but it recognizes that interpretations of what are and are not wetlands may be legitimately disputed. Presently, the Division of State Lands provides the land owner two options. One is to file a complaint through Administrative Law and the other is to file a complaint in Circuit Court. SB 1582 offers the land owner a third option to request binding arbitration that requires the arbitrators to be qualified, independent scientists. The landowner chooses one, DSL chooses one, and the two choose a third. There are prescriptive time lines for the process and the cost is shared equally between DSL and the land owner. A second

feature of the bill is that certified wetland delineations may be extended for another five years when there has been no change of conditions, and a third feature of the bill is to clarify that the Division of State Lands must comport with the 1987 U.S. Corps of Engineers Manual and any subsequent guidelines that are issued. If State law exceeds the requirements of federal law then Oregon's standards will be the same as federal standards.

**HB 4045 – Firearm CHL Information Protection Passed**

HB 4045 prohibits a public body from disclosing identifying information of a person who applies for, or currently holds a CHL. The bill provides exceptions based on certain legal circumstances or if the CHL holder consents to the disclosure in writing. Overall the bill provides added protection for CHL holders and it passed 24-5 in the Senate and 54-6 in the House

**Good Legislation Stopped**

**HB 4158 - OCA Wolf Legislation Failed - Not Given Hearing in Senate**

On February 17 HB 4158 (Called the Kill Bill) passed the House with a vote of 42 yes and 15 no. The bill was finally sent to Senate Environment & Natural Resources Committee (Chaired by Sen. Dingfelder) where it was used as trading stock for SB 1511 (Ecosystem Services) and Defenders of Wildlife amendments. Sen. Dingfelder offered to send the bill to Senate Rules Committee if the Oregon Cattlemen's Association would stay neutral on SB 1511 and agree to work with DOW on amendments to HB 4158. The DOW amendments would drastically change the Oregon Wolf Conservation and Management Plan by placing unnecessary language in statute, and SB 1511 would involve OCA in a bill that they and the Ag. and N.R. community could not support. OCA had enough votes promised in the Senate to pass HB 4158 in the engrossed version, and it is very disturbing that one Committee Chairperson with the help of the Senate President could stop much needed Legislation that was written by a member of the Department of Justice and a member of the Legislative Counsel. Furthermore, it is equally disturbing to know that the Department of Fish & Wildlife actually needed this bill and that the Governor would have probably signed it. The only thing that can now be said is that this is an example of politics gone wrong.

**Pilot Program for Hunting and Pursuing Cougars Stopped**

HB 4119 requires State Department of Fish and Wildlife to recommend rules to State Fish and Wildlife Commission regarding creation of a pilot program that allows persons to use dogs to hunt or pursue cougars. OCA has provided support for this proposal for probably 10 years now. It would really be helpful to ODF&W and the Commission to implement the Pilot Program and benefit from the results. The bill has now been referred to Ways & Means to decide whether or not the fiscal impact can be absorbed by ODF&W.

**Development of Columbia River Basin Water Resources Stopped**

HB 4101 directs Water Resources Department to aggressively pursue development of Columbia River Basin water resources in the Umatilla area. This proposal has been introduced for several Sessions and OCA has supported the concept of increased appropriations from the Columbia to benefit agriculture and economic development.

**Updating the Oregon Forest Land Protection Fund – HB 4042 Stopped**

HB 4042 was filed at the request of the Oregon Small Woodlands Association and it was intended to change the permissible use of moneys in Oregon Forest Land Protection Fund (OFLPF). The intent of this legislation was to install financial equity through all parts of the wild fire suppression and control system for landowners and the state general fund. This piece of legislation did not make it past the Ways & Means budget test, even though the impact to the budget was phased in over the next four biennium.

**Timber, Water Jobs Bills Stopped**

The 2012 session was adjourned with the rebalancing of the budget without raising taxes and achieving bipartisan compromise on health care and education reform. But, there were six out of seven jobs bills left in committee upon adjournment:

- HB 4097 - Allows working families to save and spend more of their earnings by providing tax relief to lower and middle income Oregonians by doubling the two lower income tax brackets, and providing a \$250-per-child tax credit.

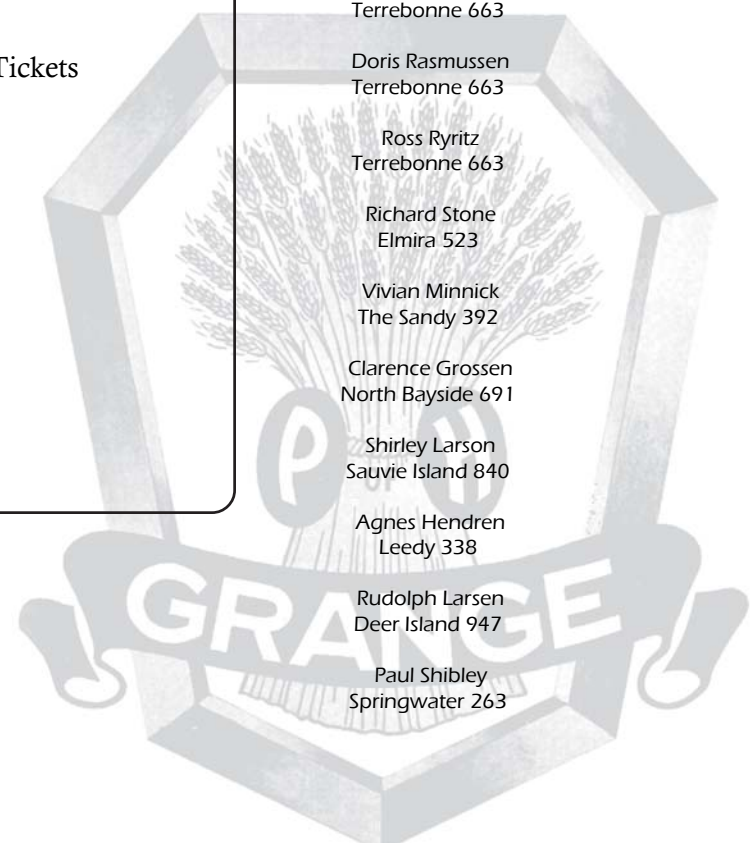

- HB 4101 - Leveraged Oregon's abundant water resources by utilizing an additional 450,000 acre feet of water from the Columbia River for agricultural use to boost direct farm and food processing jobs.
- HB 4103 - Supports Oregon's building and construction industries and trades by creating an income tax credit for capital improvements to private properties and business facilities.
- HB 4098 - Put Oregonians back to work in state forests by increasing sustainable harvesting in Oregon State Forests.
- HB 4076 - Promote investment in Oregon companies and workers making Oregon more competitive in attracting and retaining employers by establishing a two-year period when capital gains is taxed at 2.5 percent
- HB 4096 - Encourage small business to hire Oregon's long-term unemployed by giving qualified small businesses a tax incentive to hire unemployed Oregonians.

### Bad Legislation Stopped

#### Ecosystems Services Markets Legislation Stopped

OCA opposed SB 1511 which was written to expand state policy relating to ecosystems services which was established in statute in 2009. SB 1511 was introduced by Defenders of Wildlife without the full approval of those who participated in the 2011 SB 513 work group and was used as trading stock for HB 4158, but it died in the House without referral to a committee, which is good!

#### SB 1594 – Firearms Prohibited on School Property Stopped

SB 1594 would have prohibited the possession of firearms or dangerous weapons on school grounds. The bill provided for certain exceptions to this prohibition and would have allowed school districts, community colleges and the Oregon University System to adopt their own policies authorizing Concealed Handgun License (CHL) holders to carry their weapons on school grounds. The opposition to this bill stressed there is no evidence that the tragedies that have occurred in schools could be attributed to CHL holders. The bill failed in the Senate by a 14-15 vote and received no further action.

### Revenue and Taxation

#### Fiscal Stability Proposal Stopped Again

Senator Frank Morse first proposed his "Fiscal Stability Act" during the 2011 Legislative Session because he has contended that "the combination of the legislature spending it all, no planned general savings, and when the revenue forecast is off by 2% or more it serves to magnify the negative impacts to our schools and other critical public services when the economy sours. The measure would create a general purpose constitutional Emergency Reserve Fund which would be filled through a disciplined savings mechanism that limits revenue available to spend by benchmarking against the rolling six-year average rate of growth of personal income. The revenue in excess of the rolling average first fills the fund and when the balance equals 12% of the previous biennium spending, the excess revenue is returned to taxpayers. The Emergency Reserve Fund can only be used for core services in times of financial stress and it cannot be raided to grow government. An added benefit of this plan is that it reduces revenue volatility by 40%.

### Jobs and Economy

#### HB 4093 – Rural Enterprise Zone Expansion Passed

The bill increased the number of rural enterprise zones that may be designated from 17 to 20, and the number of urban/rural enterprise zones from 15 to 20.

#### HB 4040 – Oregon Investment Act Passed

The Oregon Investment Act creates the Oregon Growth Board and the Oregon Growth Fund and consolidates a myriad of economic development financing tools into one fund managed under the auspices of the Treasurer's office. However, the bill also provides the opportunity for private investors to participate with public monies invested for the purpose of an economic return. This provision in the bill represents a major public policy change and needs thorough oversight applied. The bill requires operating details of the Oregon Growth Board and Fund to be presented to the 2013 legislature for approval.

#### SB 1552 – Foreclosure Protections Passed

SB 1552 provides additional foreclosure protections for Oregonians. It requires a mandatory face-to-face meeting between homeowners and banks, with a third party mediator present to help negotiate alternatives to foreclosure. Before mediation, homeowners will meet with a housing counselor from Oregon Housing & Community Services to discuss the options available to the homeowner. The proposal also ends the dual track process that allowed banks to renegotiate terms of the loan while pursuing the foreclosure process at the same time.

The bill was worked on diligently by both the House and Senate so that a compromise could be reached that would benefit Oregonians.

### Public Safety

Legislature - Rebalanced the state budget without closing any prisons or releasing convicted criminals.

### Education

#### SB 1581 – Education Reform Continuation Passed

SB 1581 is a continuation of the efforts of SB 909 from the 2011 Legislative Session that created the Oregon Education Investment Board (OEIB) and the office of Chief Education Officer. SB 1581 outlines additional authority for implementation of the OEIB and achievement compacts. This bill was a priority for the Governor in his continued efforts to reform Oregon's K-12 education system. It passed the House 52-8 and the Senate 23-6.

### Health Care

#### SB 1580 - Health Care Transformation Continuation Passed

The initial passage of the "Transformation" of the health care delivery system for the Medicaid population began in 2011. The creation of Coordinated Care Organizations to bring the various threads of public and private health delivery (mental, physical, dental) into an integrated delivery system was established. However, the legislation did not adequately provide for reforming the medical liability system and the 2012 updates may have also fallen short. The bill provides for a Governor led task force to develop recommendations for medical liability reform to the 2013 legislature. The success or failure of CCO's will largely ride on the outcomes of medical liability reform.

#### HB 4164 – Health Insurance Exchange Passed

HB 4164 advanced the implementation of a health insurance exchange that could help make coverage more affordable to small businesses and individuals.

#### HB 4027 – liability Immunity in Certain Situations Passed

The Bill expanded immunity from liability for health care professionals who provide services for charitable organizations without compensation.

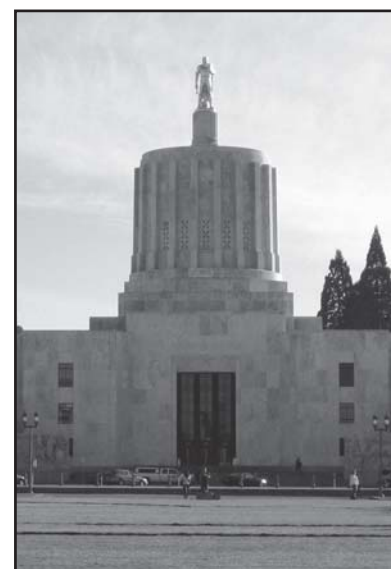
### Seniors

#### HB 4039 – Property Tax Relief Passed

The Bill provided temporary relief to seniors with reverse mortgages under the Senior Property Tax Deferral Program.

#### HB 4084 – Increase Penalties for Elder Abuse Passed

The Bill increased penalties for various forms of elder abuse, and gave law enforcement additional tools to investigate allegations of abuse.

## Oregon Grange Hall Destroyed by Easter Morning Fire

An early morning fire on Sunday, April 8<sup>th</sup>, destroyed the Ash Butte Grange hall, located in Ashwood, in the north central part of the state near Madras. Grange members were busily preparing for the Easter service that was to be followed by a potluck brunch. One of the helpers discovered smoke pouring out of the eaves of the hall. Members started removing what little they could but the fire quickly consumed the entire wooden frame structure. Instead of observing the glory of Easter morning, the Grangers and community members watched with sadness as flames destroyed the building that had been built over 120 years ago.

The few items that were saved included an antique piano, the charter, flags and some wall plaques. Everyone was ordered out of the building just before the ceiling began to collapse. The small community of Ashwood is not part of the Jefferson County Fire District. But, as members stated, even being part of any top-rated fire district in the country could not have saved the building. A member stated that the building "went up like a tinder box. It wasn't even an hour and it had fallen down in on itself."

The Grange plans to rebuild and talk is underway on how to finance the rebuilding project. Farmers, ranchers and community friends used the hall in addition to the normal Grange activities. It was the local gathering place for birthday celebrations, weddings and funerals.

Membership totaled about 20 at the time of the fire, but a meeting after the fire saw the addition of at least four (4) new members.

Oregon State Grange was pivotal in beginning fund raising efforts to help Ash Butte. National Grange was made aware of the fire and sent out a "Fraternal Concern" to Grange leaders throughout the U.S. seeking donations. A special donation account was established through US Bank and donations will also be accepted by the Oregon State Grange Foundation for individuals or businesses wanting to make a tax deductible donation. 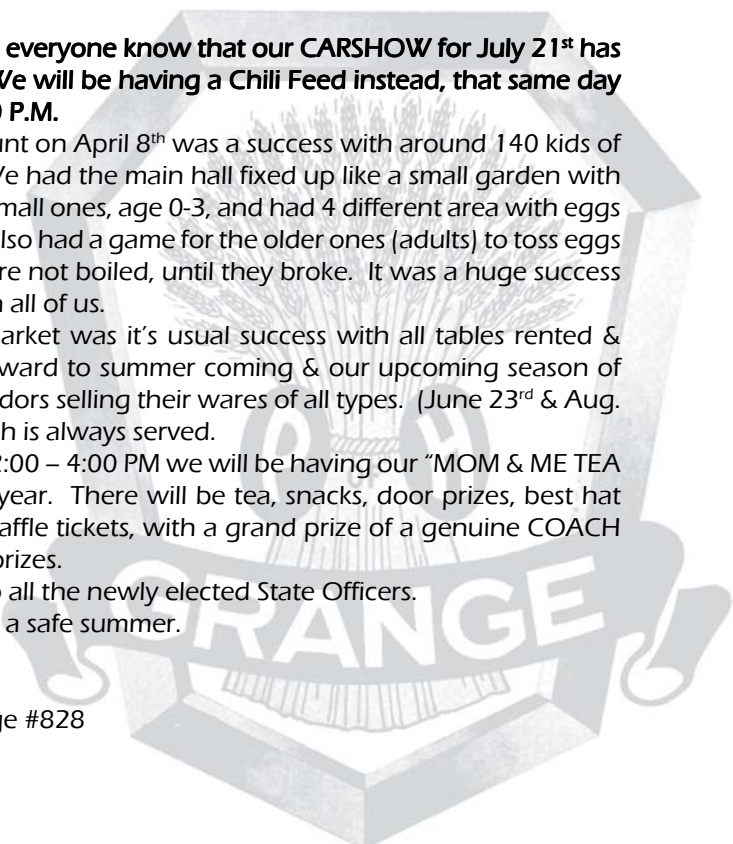

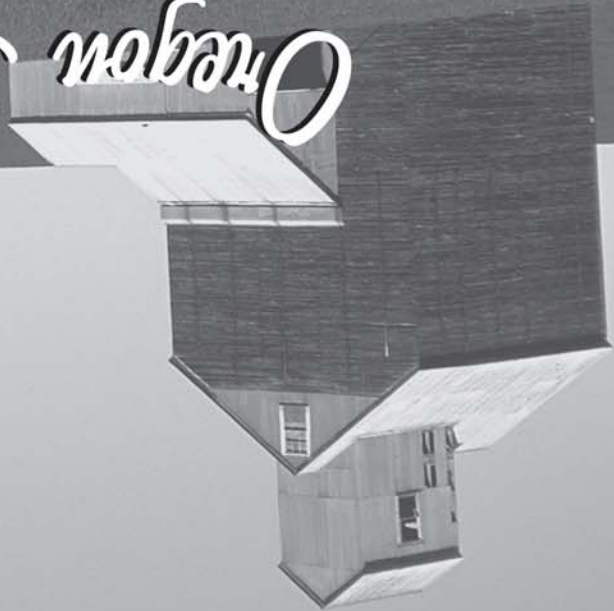

In July 2011, Grange secretary Sharon Tracy composed a letter to The Nature Conservancy in response to their solicitation for local nonprofit organizations to apply for Zumwalt Prairie Land Owner Preference tags as organizational fundraisers. The Nature Conservancy accepted her letter and awarded the Grange a 2012 Trophy Deer LOP Tag. She and Grange member Derrell Witty attended an informational meeting held by The Nature Conservancy in August 2011.

The Grange members put together a hunter's package which included the Land Owner Preference Tag (aka LOP), a 3-night stay at the 1910 Historic Enterprise House Bed & Breakfast, and guide services by Cory Miller. Local graphic artist Ed Pitts of Joseph prepared posters and a full-page print ad. The ad appeared in Oregon Hunter magazine and generated many raffle ticket sales. Grange member Clarann Witty's phone and Sharon Tracy's phone were ringing off the hook with people wanting to buy raffle tickets. Grange members hung posters in windows of businesses throughout Wallowa County. All in all, 121 envelopes with raffle ticket stubs were mailed outside of Wallowa

County and more tickets were sold within the county for a total of 258 tickets. Tickets were available from December 2011 through early March 2012, including Grange member Grace Gray and others selling tickets at the Joseph Oregon Christmas market.

Grange treasurer Linda Knifong kept busy depositing proceeds from the raffle. Both Clarann Witty and Barb McCormack assisted with recordkeeping for the drawing.

The drawing occurred on March 15th at the Hurricane Creek Grange's monthly meeting. Newest Grange member Andi Mitchell pulled the winning ticket.

Grange secretary Sharon Tracy contacted the winner. "He was absolutely overwhelmed and couldn't believe it at first. He was so thrilled!"

Jeremy's ticket was the winner among 258 tickets sold from Wallowa County to the Oregon Coast.
