## Keeping Oregon Warm a Success

Oregon's Youth and Young Adults accepted the challenge from Washington State Grange's youth to participate in "Keeping Oregon Warm" by collecting winter wear (gloves or mittens, hats, stocking caps, scarves, and socks). These items, either handmade or store bought, were brought to the State Grange Convention in June. They were sorted, counted and then packed up and sent home with Grangers from the counties in the District #2 to be distributed where they are most needed.



Connie Suing, Oregon's Youth and Young Adults Director said "I never dreamed when we decided to participate in "Keeping Oregon Warm" that it would be such a great success." And a success it was; 973 items were collected. Some of the boxes of items have already been delivered to shelters, etc in the host

counties; others will be distributed closer to winter.

Oregon's Youth and Young Adults are looking forward to working on this project again next year with a goal of collecting 1200 items. A big thank you goes to the Granges and Grangers who stepped up to the challenge. Many people will be a little warmer this year because of your generosity.

## 144th Annual Oregon State Grange Convention June 24-29

This year the Oregon State Grange Convention was held at Florence on the Oregon coast. Attendance for the six days was 258 with 63 Subordinate/Community and eleven Pomona Granges represented.

Eighty-five resolutions were voted on with many issues debated. A highlight of the Legislative part of the convention was a report on the ongoing opposition by Grangers to Oregon Senate Bill 181 which if adopted would have subjected many Oregon non-profits to yearly reporting to their county assessor or face losing their exemption from property taxes. It was unclear if this would have affected all Granges or only some Granges, depending on how they were registered, but would have for sure affected many of the Grange's non-profit partners. During convention the pressure on the legislature, which was still in session, was stepped up with a social media, email and postcard campaign. More than 80 postcards were sent from convention attendees to their legislators reminding them of the Grange's opposition to SB181. The bill, adopted by the senate, died in the house committee upon adjournment in July.

### Highlights of State Convention

Another State Convention has come and gone! During the week we worked over 80 resolutions that set policy for the coming year, we enjoyed the talent contest, we were blessed to have youth and juniors present and presenting their programs, and the GrangeUp pep rally energized us at the end of a long day. In short we had a great week! I want to thank all our members who came and took part in the activities. My only regret is that we only had members present from 68 Subordinate Granges. Next year let's get that number up to over 100!

We welcomed our National Master, Sister Betsy Huber, who spent the week with us. I hope each member present took time to talk to Sister Betsy, and to welcome her to our great state. I know she had a good time and felt welcomed by all.

One of the resolutions adopted will change the minimum fee for Life Memberships. The current life membership minimum fee is \$250. As of September 1<sup>st</sup> this will increase to \$450 in an effort to keep pace with the annual dues. The resolution actually says that the new minimum fee will be ten times the annual dues, so any rise in our dues structure will also raise the life membership fee. If your Grange is charging the minimum fee of \$250 you will have to raise your fee to \$450. If your Grange is already charging more than \$450 you are still in compliance.

We also reiterated our support for funding the Department of Veterans Affairs and have pledged our support for legislation that supports the at-risk and disadvantaged senior citizen

population of Oregon's rural counties. Information on all of the adopted resolutions can be found on our website.

SB181 was also the topic of a few of the resolutions. We not only passed a resolution expressing our opposition to this bill, but many of our members also sent postcards to their State Legislator. Our new Lobbyist, Craig Loughridge, followed this bill very closely and finally announced that as of the close of the 2017 Oregon legislative session, the bill had not come out of committee. I want to congratulate all the members who stepped up to write to their representative, or took the time to give testimony at one of the hearings. I believe that we had one of the strongest voices opposing this bill.

### GrangeUp

If you weren't at the State Convention you missed the pep rally Monday night where we celebrated the successes we have seen with the GrangeUp program, and encouraged all to keep up the momentum. While we still have a long way to go, we are seeing a net gain as of the second quarter! Remember the state office can supply you with brochures, Bulletins & GrangeUp buttons if you have an event coming up. Just let us know what you need, and we will be happy to send it out. Increases in membership go a long ways toward helping your Grange make a difference in the community. And remember at the end of the year three lucky and hardworking Granges will win a cash prize and six will win an ice cream social! So keep adding members and get your percentage up there!

What a year it has been. What troubles me the most is the extreme hate and discontent that is all around. The stabbings in Portland, the news of mothers killing their children and children killing their parents. It is all so virulent and so repulsive. It makes us want to run and hide. Anything to make ourselves, our children and our friends safe. I wake up every morning and dread turning on the news. It is so negative and so focused on reporting the bad, the sensational and none of the good. It is no wonder Americans have become desensitized to the pain and suffering of others. ## Adopted Resolutions That Changed Grange By-laws or Operations

**BL #2: Update Deaf Awareness/Family Health Committee Name**  
**Resolved:** Oregon State Grange change "Deaf Activities" to "Deaf Awareness" in the following sections: 1.13.10(d)(2), 1.15.1(a), 1.15.5, 3.8.3, 4.15.2

**BL #3: Election Board for Preferential Election**

**Resolved:** **Article 1 Section 9, Preferential Election 1.9.1** be changed to read: "Not later than April 1 of the year in which a Preferential Election is to be held as herein provided, the Master of the Oregon State Grange shall appoint an Election Board, consisting of six Pomona Masters, **Past Pomona Masters, County Deputies, and/or past state officers** and other members as needed. The Board shall canvass the reported ballots of Preferential Election and report its findings to the State Master."

**BL #4: Nomination Deadlines for State Officers**

**Resolved:** **Article 1 Section 8, Officer Nominations 1.8.1 (a)** be changed to read: "At any regular meeting in **November or December of odd years** or January of even years, Subordinate/ Community Granges may, by majority vote, present the names of members to become candidates for the offices of the Oregon State Grange. The names of such members must be presented by a minimum of one Subordinate/ Community Grange before their names can be entered on the Preferential Election ballot." And be it further

**Resolved:** **Article 1 Section 8, Officer Nominations 1.8.1 (c)** be changed to read: "The names presented shall be filed by mail or electronic means with the State Office not later than 5:00 p.m. **January 25**. Results of the nominations listing all members receiving one or more nominations and the Granges from which they were received shall be published in the February issue of the Grange Bulletin."

**BL #5: Life Membership Minimum Fee**

**Resolved:** The Oregon State Grange raise the minimum fee for a Life Membership to ten times the minimum annual dues and rewrite **Article 4, Section 7.2 Life Membership** of the By-laws to read: (a) The minimum fee for a Life Membership for a current member shall not be less than **ten times the minimum annual dues**. A Grange may increase the minimum fee charged for such Life Memberships by making a provision in its By-Laws.

**BL #6: Life Membership Interest Returns**

**Resolved:** The Oregon State Grange shall credit the interest return from the annual Life Membership return for each Subordinate/ Community Grange from the second quarter report bill before being sent. And be it further

**Resolved:** Oregon State Grange By-Laws section of Life Membership, sub-section 4.7.10 **Investment Income Return, section (a)** be rewritten to read: "(a) By the fifteenth (15th) day of **May** the income generated by the investment of the Life Membership Fund be credited to the participating Subordinate/ Community Granges. This income shall be paid on a pro-rata basis determined by the balance of the Life Membership Fund at the beginning of the previous year. **No later than the second quarterly report, the income generated by the investments of the Life Membership shall be credited against the amount of dues to be paid by the Subordinate/ Community Grange for the second quarter.**"

**BL #7: Pomona Grange Dues**

**Resolved:** **Article 3 (Pomona Grange) Section 4 Dues** have the following added: "3.4.4 If a Subordinate/Community Grange is not part of an organized Pomona district, then the Pomona dues collected shall be held in trust for the district that Grange is a member of and then forwarded to the State Grange hosting district that Grange is part of instead of being paid to a Pomona Grange. These funds shall be forwarded in February of the year that district is hosting State Grange."

**BL #8: State Executive Committee Members**

**Resolved:** **Section 8, Officer Nominations 1.8.1(b)** be changed to read: "Nominees for the offices of Executive Committee shall be a member of a Grange within the counties assigned to the position and shall be nominated and elected by the state at large. These

## Minimum Fee for a Life Membership Raised Effective September 1, 2017

After much discussion By-laws Resolution #5 Life membership Minimum Fee was adopted at this year's annual OSG convention. For the last several conventions there have been resolutions to raise the minimum fee but this is the first time the fee has been tied to the amount of dues paid.

Effective September 1, 2017 the **minimum fee for a Life Membership will be not less than ten times the minimum annual dues**. Current minimum annual dues are \$45 so that makes the **minimum fee for Life Membership \$450**. This is just the minimum. A Grange may increase the minimum fee charged for such Life Memberships by making a provision in its By-Laws. Also if (when) Grange dues go up in the future the minimum fee

will automatically rise as well.

At current interest rates this will not solve the problem between what the annual dues for a member is and what a Grange receives from the Life Membership Fund but is a step in the right direction. This does not affect those members who already have Life Memberships, only those buying memberships after September 1, 2017.

Granges are encouraged to look at their By-laws and consider raising their Life Membership fee above the minimum required by the State Grange By-laws. Additionally, Granges that have the Life Membership program in their By-laws may need to update them with the new minimum fee.

## The Agricultural Report

I would like to congratulate John Eveland and Sally Brewer as the recipients of the OSG Agriculturalists of the Year Award for 2017. They applied together as they said they could never have achieved what they have without their supportive partnership.

They are members of Marys River #685 in Philomath and own Gathering Together Farm which they began, just the two of them, 30 years ago on five acres. Now at 60 acres they have gross sales of \$2.5 million, with an annual payroll of \$1.2 million and seasonal employment of up to 120 people. Their organic farm annually participates in eight farmers markets, including four simultaneous Saturday markets. They also run a roadside farm stand and a highly regarded farm restaurant, serving dishes featuring their farm produce. The kitchen bakes their own bread and pastries, and makes their pasta.

These farmers have mentored many young farmers, hosted tours and conferences, and been active in the development of organic techniques and global standards. They have played a major role in organizing and sponsoring a monthly medical clinic for under-insured farm workers and their families, which is hosted at Marys River Grange Hall. John and Sally were also pivotal in recruiting almost 50 new Grange members in 2009 when Marys River Grange voted to close, after the remaining older members lost hope of being perpetual.

On another tack, in Salem there was some good news. HB 3249 was passed to establish the Oregon Agricultural Heritage Fund. This collaboration between agriculture and conservation groups will develop programs and strategies for Oregon farmers to take advantage of federal and other grant programs, promote conservation of working agricultural lands, and developed programs for succession in agricultural lands.

HB 2038 passed to provide \$4.5 million for Farm to School purchases of Oregon agricultural products by schools. This was after early budget proposals had zero funding for this program.

SB 181A was not brought to a vote after widespread concern about negative effects on non-profits like the Grange. This bill would have required a new annual report to the county assessor for each tax exempt organization. The assessor would judge the validity of the tax exempt status and be able to assess a penalty of five years taxes at 16% interest to those judged undeserving. The Grange was concerned about possible harm and we are pleased this did not become law.

At the Oregon State Grange Convention the Agriculture Committee had an interesting Ag Tour, visiting a farmers market and hearing about local marine fishing. We also had two conferences with good speakers. Hope more of you can come to the State Grange Convention in Astoria in 2018.

## Abernethy Grange Installs AED

Almost a year ago Abernethy Grange #346, Clackamas County started the process of acquiring an AED (Automated External Defibrillator) for their Grange hall. It was brought to their attention by member Tom Gay that as an active Grange with many rentals that installing this life saving device would be of benefit not only at Grange functions but for those groups renting the hall.

It was determined that the total cost to acquire the machine and installation would run just under \$1600. The Grange received a grant to help in procuring the machine from the Clackamas Emergency Services Foundation. Additional money was donated by groups that rent the hall, including B&B Square Dance club, Early Ford V8 club, NW Vintage Radio Club and Randy

Dibble whom teaches square dancing at the Grange.

Recently, with the help of the grant and donations the Grange was able to install the AED along with signage in the Grange hall. The Life Medical and Safety Company, through who the machine was purchased, offered a training class at the hall which was attended by Grange members and several people representing those groups that rent the hall on the operations of the AED. There will be ongoing expenses for batteries and replacement pads if the machine is used which the Grange will cover.

Abernethy Grange suggests that others Granges look into acquiring this machine for their halls and check with their local Fire Departments and foundations on availability of grants.

## 'Heads Up' Football Program Tackles Concussion Danger in Kids

A concussion prevention program that teaches young football players safer ways to block and tackle was tied to about a one-third lower risk of head injury, according to a new study.

And, in those players who *did* sustain a concussion, recovery was 27 percent faster for those involved in the program, the researchers found.

"It is difficult to say which aspect of the program did this," said one of the study's authors, Dr. John Tokish. He's a professor of orthopaedics at the University of South Carolina School of Medicine in Greenville. Tokish, a former football player and youth coach who's also the father of two football players himself, said the findings are encouraging.

"I think the results are promising," he said. "However, they spur more questions that we are anxious to go after. It is certainly possible that further research would demonstrate different results. But hopefully all of it will serve to improve the program and ultimately result in lower concussions in our young athletes."

Dubbed the "Heads Up" program, players are taught to lead with their shoulders when tackling an opponent rather than hitting the ball carrier head first. In addition, the program teaches concussion awareness and proper fit for a helmet.

The program began with three pilot programs in 2012. Heads Up is now used by more than 7,000 youth and high school football programs across the United States, according to USA Football.

The current study looked at more than 2,500 high school football players from 24 schools in the Greenville, S.C. area over the course of the 2015 season. At least one coach from 14 of the schools had previously taken the Heads Up training program while 10 of the high schools utilized what the researchers called "standard training."

The researchers randomly monitored

the football teams three times during the season to ensure coaches were teaching tackling correctly. Athletic trainers at each of the 24 schools monitored and recorded injury information for all practices and games. To ensure uniformity of care, each school used the same health care provider network to treat players who suffered a concussion.

Over the course of the season, there were 117 concussions among the players. Players on the teams using the Heads Up program sustained about one-third fewer concussions, the study found.

Players in the Heads Up group were able to return to play in 11 days while those in the non-Heads Up group were out of action for 15 days, the findings showed.

A doctor who was familiar with research but wasn't involved with the study said he wasn't sure that the new program is the panacea some are suggesting it is.

Dr. Wellington Hsu, a professor of orthopaedic surgery at Northwestern University, said, "Unless we can see better numbers and more data, this is not really that significant."

Plus, football players aren't the only ones suffering from concussions. Hsu recently looked at concussion data for high school athletes over the past decade. He found that girls who played soccer were most susceptible to these brain traumas.

"Concussions are becoming a very big problem in younger athletes and they may be having a more significant effect on these athletes' brains," he said. "All of these studies are good at raising awareness."

The study was presented at the American Orthopaedic Society for Sports Medicine in San Diego. Findings presented at meetings should be viewed as preliminary until they've been published in a peer-reviewed journal.

The recent Oregon State Grange delegate convention in Florence saw a lot of activity, and many details are presented elsewhere in this issue of the Bulletin so this column will be a bit wider in scope. We had many good discussions and heard diverse viewpoints presented in a civil and organized manner. I can't stress enough how important this is, for only through consideration of all viewpoints can we arrive at fair and equitable decisions. Working several months as your government affairs representative has shown me how powerful the Grange can be when Grangers work together. The collective action of Grange delegates this summer has brought more focus to our future policy direction. Bigger still, Grangers from all corners of Oregon came together this year to fight and defeat Senate Bill 181, legislation that posed a significant risk to local Granges and their local charitable partners.

It has been a joy for me to meet so many new Grangers online and in person as I work to keep us all informed of happenings in the Capitol. Building an alliance with the Nonprofit Association of Oregon to defeat SB 181 introduced me to more wonderful people, and expanded the message of the Grange more than we could have on our own.

The 2017 legislative session will be in the past by the time this article reaches your mailbox. Some good bills will have become law, and some bad ones will have as well. But now is the time to look to the future, and plan for legislative sessions to come.

The 2018 session, which starts in February, is scheduled to be short. However, depending on future

events, and on political pressures brought to bear on lawmakers, a special session could also come next year.

Political interest groups already are lining up to pose more ballot initiatives that would create mammoth tax increases. The threat of those measures looming over lawmakers' heads in February could sway some Republicans to compromise on lesser tax increases.

Whatever your personal ideology or political affiliation, reading *The Capitol Granger* e-newsletter is one way to stay up to date on major bills in the legislature. The newsletter roots out major points, and summarizes them in a single page.

*The Capitol Granger* comes out weekly when lawmakers are in session, and monthly when they're not. Being a subscriber also makes sure you receive alerts about bills important to your fellow Grangers, and calls to action when the Grange needs help to support or defeat a bill.

## Senate pulls off surprise finish as anti-nonprofit bill dies in committee

Senators on Friday July 7 pulled off something of a surprise, and closed days earlier than some Capitol watchers had expected. With the Senate closed, representatives in the House had little choice but to close too. The closure left dead a bill that the State Grange had been fighting. Senate Bill 181 was still hung up in the House Committee on Revenue as lawmakers adjourned.

Read on for a wrap-up of some other bills we followed:

- HB 2012: Creates eastern Oregon economic region.
- HB 2017: New taxes for transportation projects.
- HB 2038: Farm-to-school program funding.
- HB 2391: New taxes on hospitals & health insurance.
- SB 229: Dictates election dates if people refer HB 2017 or HB 2391 to a statewide vote.
- SB 1051: Sets deadline for affordable housing reviews.

### Failed

- HB 2282: Changed definition of farm use.
- HB 2382: State to work with FFA to help Ag students.
- HB 2830: Gross receipts tax.
- HB 3469: State study of government efficiency.
- SB 230: State to work with FFA to help Ag students.
- SB 307: Allowed some public use of marijuana.

OSG convention is over and the Veterans had some favorable comments about our displays and project. We had a “**Table of Remembrance**” at the entrance to the dining area, and out in the main hallway an 8’ display table with information about women veterans and the “**I am not invisible**” project, (thank you’ *Kim Schettig*) and then the Merchant Marine as a branch of service. In the session hall during Salute to Veterans, recognition by our Juniors, excited as usual, presented each veteran with a special pin “I’M A VET – The Grange thanks you”.

Planning ahead we need to be thinking about next year’s convention in Astoria. Being about the closest thing Oregon has to a military town, with all of the Coast Guard stations, museums and Camp Rilea within a couple of miles of the convention site. Maybe we could do a tour or something. Anyway, thinking caps on, start planning.

Thinking of planning ahead, Veterans Day (11-11-17) is less than three months away and the Albany Veterans Day Parade is on our agenda. Many of our Grangers will be attending the National Grange

The following is to alert veterans and their families about some of the changes that are being enacted and as Grange members we need to share this concern with everyone in our circle of friends. Recently the US Congress approved legislation making it easier to demote, suspend and fire VA officials.

U.S. Secretary of Veterans Affairs Dr. David J. Shulkin announced his decision on the next-generation Electronic Health Record (EHR) system for the Department of Veterans Affairs (VA). Having a Veteran’s complete and accurate health record in a single common EHR system is critical to that care, and to improving patient safety. —

Our current VistA system is in need of major modernization, health information technology and cybersecurity, getting VA out of the software business, because of that, we’re making a decision to move towards a commercial off-the-shelf product.

At the VA, almost all of our Veteran patients come from — from the DoD (Department of Defense), and for this reason, Congress has been urging the VA and DoD for at least 17 years — to work more closely on EHR issues. —To date, VA and DoD have not adopted the same EHR system. Instead, VA and DoD have worked together for many years to advance EHR interoperability between their many separate applications — at the cost of several hundred millions of dollars — in an attempt to create a consistent and accurate view of individual medical record information. — While interoperability between VA and DoD for key aspects of the health record, seamless care is fundamentally constrained by ever-changing information sharing standards, separate chains of command, complex governance, separate implementation schedules to accommodate those changes from separate program offices that have separate funding appropriations, and a host of related complexities requiring constant lifecycle maintenance. The bottom line is we still don’t have the ability to trade information seamlessly for our Veteran patients and seamlessly execute a share plan of care with smooth handoffs.

For these reasons, I have decided that VA will adopt the same EHR system as DoD, now known as MHS GENESIS, which at its core consists of Cerner Millennium. VA’s adoption of the same EHR system as DoD will ultimately

result in all patient data residing in one common system and enable seamless care between the Departments without the manual and electronic exchange and reconciliation of data between two separate systems.

Additionally, we have looked at the need for VA to adopt significant cybersecurity enhancements, and we intend to leverage the architecture, tools and processes that have already been put in place to protect DoD data, to include both physical and virtual separation from commercial clients.

Let me say what lies ahead, as this is just the beginning of the process.

- VA has unique needs and many of those are different from the DoD. — For this reason, VA will not simply be adopting the identical EHR that DoD uses, but we intend to be on a similar Cerner platform. VA clinicians will be very involved in how this process moves forward and in the implementation of the system. In many ways VA is well ahead of DoD in clinical IT innovations and we will not discard our past work. And our work will help DoD in turn.
- Furthermore, VA must obtain interoperability with DoD but also with our academic affiliates and community partners, many of whom are on different IT platforms.
- Therefore we are embarking on creating something that has not been done before — that is an integrated product that, while utilizing the DoD platform, will require a meaningful integration with other vendors to create a system that serves Veterans in the best possible way.

## OSG Executive Committee Meeting Minutes - April 1, 2017

The meeting was called to order at 9:10am by Master Susan Noah. Present included Sarah Kingsborough, Celia Luttrell, Roger Wilson, Don Sether, and Jeff Dehne. Carol Everman joined shortly after we started.

Prior meeting minutes from January 21<sup>st</sup> were read and approved as corrected. Thank you to Mark Noah who filled in as the pro-tem Secretary since Sarah Kingsborough was absent.

### Financial Reports

#### Celia – Current Reports

- We received 2017 funds from GIA – new allocation \$4,475.00 per quarter - \$17,900 per year. This is a reduced amount from previous years. The funds that come from GIA go into the Leadership/Membership Fund that helps cover Grange programs, committees, and leadership training activities.
- National Grange in 2017 is hosted by the Western Region. Some expenses will be covered by the National Grange Convention fund. We will also have responsibility as one of the host states. More to come as the year progresses.
- Jan's reports – We reviewed the membership reports and discussed a few Granges that have low membership. Our officers and deputies have visited most of these. We hope our GrangeUp '17 Campaign this year will help all of our Granges grow and thrive again. A handful of Granges are late with Quarterly Reports, dues, and fees.
- Loan update – Granges with outstanding loans to the OSG were reviewed.
- EC to look over Visa & Master Card bills for audit purposes.

#### Scott Barker – Barker Wealth Advisors

- Scott provided us with the investment reports through March 30<sup>th</sup>, 2017. Our rate of return thus far this year is 2.94%. We are on track with the OSG investment policy. Scott reviewed recent market trends which show growth and low volatility despite recent press/politics. The market is high which gives some people concern. It's best to manage through uncertainty with conservative and diverse investments.
- Scott will be attending our 2017 Oregon State Grange Convention to address the delegate body. Susan will coordinate with Scott on the schedule for Monday/Tuesday.

### Unfinished Business

- Restraint of Title work – still need to cover the following counties: Baker, Clackamas, Crook, Jackson, Jefferson, Curry, Lake, Malheur, Josephine, Marion, Tillamook, Washington, Wheeler. All others have been filed and are on record.
- Don made a motion that the office will continue work on this, and we will revisit at our July Executive Committee Meeting. If there are counties/properties that are more complicated, then we may refer the remaining properties to the attorney to complete. Motion was seconded by Celia and carried.
- Employee Handbook and Employee Evaluations are still on the "to do" list for 2017.
- Deer Creek Grange – We reviewed a first draft of the ground lease for the property at Deer Creek Grange with the Illinois Valley Volunteer Firefighter's Association. Deer Creek and The Firefighter's Association will have the opportunity to review and edit this draft before a final one is complete.
- GrangeUp '17 – we're excited to report that the promotional boxes and banners have been presented to 148/169 of our Granges across Oregon. 11 are slated to go in April, the other 10 are pending communication with the volunteers. Overall feedback from Granges has been very positive. The budget was reviewed.
- Sarah moved to increase the budget by \$5000 to cover the cost of travel that has come in a little higher than expected, and the new member gifts in anticipation of more than the budgeted 340 new members. Celia seconded, the motion carried.
- Virtual attendance at meetings – OSG and the National Grange passed resolutions in 2016 to allow for virtual attendance at Subordinate meetings. Susan will create a draft of policy for virtual attendance at Subordinate meetings. We will review at our next meeting and present the changes at the OSG State Convention this June.

The Executive Committee adjourned for lunch from 12:40pm to 1:15pm.

- Financial reports for the end of 2016. The balance sheet, dormant funds, trust funds, and other accounts were reviewed and discussed.

### New Business

- Lobbyist – The OSG does not currently have a contracted lobbyist. There will be a resolution at the 2017 OSG Convention to hire a lobbyist using funds from another fund. We have a desire for our organization to continue being represented in the legislature, and to provide regular communications of legislative action/activities. Some of the OSG policies are out dated. Susan will again encourage the legislative committee to draft resolutions for this year's convention that will make our policy more current.
- Don moved to offer \$2000 on a contract level to have a lobbyist/representative for the remaining 2017 Oregon State Legislative session. Jeff seconded and the motion carried.
- Keizer Grange has closed and been declared dormant.
- Request from Riversdale to sell the Evergreen property for \$150,000.
- Jeff moved that Evergreen Grange be authorized to proceed with the sale at \$150,000. Sarah seconded and the motion carried.
- Request from Netel Grange for funds not to exceed \$17,500 for a new septic system, which is a high-end estimate.
- Jeff moved to extend a loan to Netel Grange for the amount of the invoice to be repaid in a 100 month term at 5%. Don Seconded. Sarah made a motion to amend to offer a maximum term of 10 years / 120 payments. Discussion followed regarding the request and affordable loan terms. The amendment carried. The motion, as amended, carried.
- The OSG building in Salem is in need of a new draft inducer for the heating/cooling unit. – total cost \$507.00
- Jeff moved to replace the draft inducer and the fan in the men's room. Don seconded. Motion carried.
- Ivy is starting to crawl over the roof of our building, and needs to be removed before it does damage to roof or heating/cooling system. Don volunteered to work on the ivy.
- Mohawk-McKenzie has been meeting at the Willakenzie Hall for several years. The OSG office will draft a hall use agreement as Willakenzie is currently under the Dormant Grange restriction.
- Library presentations on the 150<sup>th</sup> Anniversary. Marilyn Reiher and Jay sexton have put together a 150<sup>th</sup> anniversary display for placement in libraries throughout the state of Oregon. Several libraries have already committed to displaying Grange information this year.
- Roger moved to allocate \$1500 for the 150<sup>th</sup> Anniversary library promotion. Don seconded. Jeff moved to add travel expenses, in the form of mileage reimbursement, on top of the \$1500. Roger seconded. The motion, as amended, was carried.
- Gold Hill – The property is for sale and has a few repair needs, including the furnace.
- Jeff moved to pay the bill for the Gold Hill furnace and take the remainder under consideration as it comes up. Don seconded and the motion carried.
- The National Grange shared communications regarding grants by the USDA that Granges might be eligible for. Jeff volunteered to research this and report back.
- Oregon Agricultural Heritage Program – Legislative Hearing April 4<sup>th</sup> with several other agriculture organizations.
- Growing Oregon magazine – in 2016 we had an ad in the magazine.
- Don moved to authorize an ad for the 2017 magazine. Jeff seconded and the motion carried.
- State Grange Officer dresses will be used for OSG Convention and the 2017 National Grange 6<sup>th</sup> degree team.
- Don moved to allocate \$100 for each dress, the remainder of the dress cost is up to each state officer. The funds come from the National Grange fund since they will be used for this year's National Grange Convention. Roger seconded, motion carried.

### Decisions made via email

- Agreement to counter the Gold Hill offer to \$140,000, and giving the Master the authority to go as low as \$130,000 if necessary.

## Public Policy Resolutions Adopted at the 2017 OSG Convention

### AG #5: Active Support for Ending Neonicotinoid Use by General Public

**Resolved:** Neonicotinoids be available only to certified and licensed applicators.

### ED #1: Textbook 'Get Oregonized' for Oregon Classrooms

**Resolved:** The Oregon State Grange endorses textbooks in our public schools that present agricultural practices realistically and honestly. And be it further

**Resolved:** The Oregon State Grange endorses the book entitled 'Get Oregonized' as such a textbook. And be it further

**Resolved:** The Oregon State Grange Education Committee encourages local Granges to work with their local schools to get 'Get Oregonized' adopted as a textbook and develop guidelines/talking points for local Granges to use to accomplish this goal.

### ED #2: Resolution Opposing Common Core State Standards

**Resolved:** Oregon State Grange will lobby the Governor of Oregon to withdraw from the CCSS and keep K-12 education student-centered and accountable to the people of the State of Oregon.

### ED #3: High Stakes Testing

**Resolved:** The Oregon State Grange calls on the governor, state legislature and state education boards and administrators to reexamine public school accountability systems in this state and to develop a system based on multiple forms of assessment that do not require extensive standardized testing, more accurately reflect the broad range of student learning, and are used to support students and improve schools. And be it further

**Resolved:** The Oregon State Grange petition the National Grange to lobby the U.S. Congress and administration to overhaul the Elementary and Secondary Education Act (currently known as the "Every Child Succeeds Act"), reduce the testing mandates, promote multiple forms of evidence of student learning and school quality in accountability, and not mandate any fixed role for the use of student test scores in evaluating educators.

### ED #4: Support for the Oregon FFA Association and Agricultural Education

**Resolved:** The Legislature continue funding the FFA Association and vocational agriculture programs. And be it further

**Resolved:** The Oregon State Grange lobby the Oregon Legislature to include state funding for the Oregon FFA Association and agricultural education in Oregon schools.

### ED #8: Saving the Criterion School Campaign

**Resolved:** The Oregon State Grange endorses the efforts of the Oregon Retired Educators Association (OREA) to repair the Criterion Schoolhouse and sustain this building as a symbol of and tribute to Oregon public education.

### EE #2: Support for Increased Aluminum Recycling

**Resolved:** The Oregon State Grange encourages any legislation that would increase aluminum recycling. And be it further

**Resolved:** If adopted by the Oregon State Grange, this resolution will be forwarded to the National Grange.

### FiA #1: Opposition to SB 181 and Changes to Tax Exempt Status

**Resolved:** The Oregon State Grange urges the 2017 Legislature to reject SB 181. And be it further

**Resolved:** The Oregon State Grange opposes changes to or removal of tax exempt status of fraternal, charitable, and religious non-profit organizations.

### HW #2: Senior Health Care in Oregon

**Resolved:** The Oregon State Grange will advocate for legislation supporting the at-risk and disadvantaged senior citizen population of Oregon rural counties.

### LE #1: Prohibition of Gerrymandered Political Districts

**Resolved:** The Oregon State Grange supports legislation at all levels that requires political district boundaries be drawn by a non-partisan commission with the goal of having simple boundaries representative of the population upon which they are drawn.

### TR #1: I-5 Donald/Aurora Exit

**Resolved:** The Oregon State Grange urges ODOT, Mid-Willamette Valley Area Transportation Commission and Marion County to fund and implement project #19062 – The Donald/Aurora Interchange on I-5 exit 278.

### UT #4: Oregon State Grange Energy Policy

**Resolved:** The 2017 Session Utilities Committee approves the following to be added to the Oregon State Grange Energy Policy:

- Develop an energy policy to promote the economic and efficient use of our natural resources to produce energy.
- Develop all energy sources that are feasible using proven technology.

### VT #1: Lottery Funds for Veterans

**Resolved:** The Oregon State Grange opposes any reduction in the funding of the Oregon Department of Veteran Affairs from Oregon's General Fund and supports the addition of the 1.5% Oregon Lottery Funds to be used for the benefit of our veterans.

### Reaffirmed Policies

Additionally, there were many resolutions pertaining to the reaffirming of policies that were scheduled to sunset on July 1, 2017. Those reaffirmed by the delegates are available on the Oregon State Grange website on the Legislative page and will be printed in the 2017 Convention Proceedings.
